At that time, the Job Description will also be made available for potential candidates and the interviewing process will begin. Representatives of the Transition Committee will meet with the Rabbinic Search Committee to share the Survey data to assist in formulating many of the questions to be posed as part of the interview process. (As its final task, the Transition Committee will present and review the Survey data with the general membership at the next scheduled membership meeting.)

2. Rabbinic Search Committee:

Once the Job Description has been finalized, the baton will be passed to our Rabbinic Search Committee. Along those lines, I am excited to announce that our Board has approved the recommendation of the Executive Committee for the following individuals to serve on the Rabbinic Search Committee:

It is my hope that, with this group, each member of the Shul feels that his or her interests are being represented in the search for our new Rav.

As its first task, and as mandated by the Shul's Constitution, the Search Committee presented to the Board at last week's meeting the proposed "Search Process" to be used. That Process, with some insightful modifications and additions made by the Board at the meeting, was unanimously approved and adopted. It will be uploaded to the Shul's website, where it can be viewed by the membership in the coming days.

3. Probahs:

As detailed in the uploaded Process, one of the highlights of the rabbinic search will be the opportunity for the finalists to come to CBY for a Shabbat to interact with the membership. This is commonly referred to as a "Probah." In order for our members to plan their travels accordingly, please note that the weekends set aside for the Probahs are February 14, February 28, and March 6, with March 27 set aside as an alternate.

4. Compensation Committee:

I will be chairing a Compensation Committee, whose task will be to create an overall compensation package for our new Rav. That task will begin now with extensive research to determine the general parameters that shuls similar to CBY in size, stature, geography, etc. pay their rabbanim, and it will conclude in or around April (iy"H!) with negotiating the eventual employment contract of the new Rav.

5. Tribute Committee:

Lastly, a Tribute Committee is being established to formulate and formalize the many ways we hope to pay tribute to our dear Rabbi and Karen Pruzansky for their decades of service to our kehilla.

To conclude, 5780 should prove to be an exciting year for CBY, and a year that will shape our future for generations to come. As such, this entire process is one that should be enjoyed and experienced by each and every member. It will be my goal throughout this year that these processes, as they unfold, be as open and transparent as possible.
