



SALE OF CHAMETZ

On Pesach it is forbidden to keep Chametz, its mixtures and/or derivatives in one's possession. All Chametz not destroyed must be sold to a non-Jew. Bedikat Chametz (searching for leaven) takes place on **Thursday evening, 29th March 2018**. Thus the formal sale of Chametz to a non-Jew takes place on Friday morning, 30th March 2018.

The Shule office will need your form by 12 noon, Tuesday 27 March 2018, so please keep this in mind if you are sending via snail mail.

Responsibility cannot be accepted for forms reaching the Rabbi after this time.

Please note the procedure for the Sale of Chametz.

1. The Rabbi is appointed as an agent of the seller of the Chametz to sell it to a non-Jew or to appoint someone else to sell it. As a result, the non-Jew is then allowed free access to the Chametz he purchases.
2. This procedure is a bona fide sale in accord with Talmudic and secular law.
3. It is prohibited to derive any benefit from Chametz which has been kept by a Jew during Pesach.
4. Should one find Chametz in one's house during Chol HaMoed, the Chametz should be burned (or destroyed). If found on Yom Tov, one should cover it with a vessel until the conclusion of Yom Tov and then burn it.
5. The sale of Chametz Form can be mailed, faxed, emailed, handed in to the Office or may be handed in to Rabbi Genende personally after Shacharit Tefilot, not later than **12 noon, Tuesday 27 March, 2018. Final mailbox clearance Tuesday 27 March.**
