## Worship:

Our summer services were well attended, especially those when we served dinner (about 70-80 compared to 30-40 on non-meal nights). There is a good vibe around worship. Last Friday night 150 people gathered to formally welcome Cantor and Rabbi Berlin, share camp reflections, listen to the band, and eat together. We will plan periodic instrumentally enhanced Shabbat services throughout the year, with dinner before or after too.

In addition to the High Holy Days, we have plans for a nice Sukkot service on Sept. 29 and a combined Intergen, Consecration, and Simchat Torah service planned for Oct. 6.

During the year, we plan to read Torah on Friday nights once per month, and will be reaching out specifically to people who used to chant Torah on the High Holy Days. I've heard from a few that they miss it, and we want to give them an opportunity.

## **High Holy Days:**

#### **Honors**

95% of the individual honors have been assigned. There are a few lingering for Yom Kippur but will be assigned this week.

Rosh Hashanah Group Aliyot invitations have been sent. They are for the Golf Tournament Volunteers, Code Blue volunteers, and the Cantorial Search Committee.

Yom Kippur Aliyot will be for All SHAFTY Board, Madrichim and the Confirmation class; all b.mitzvah since last year; all Purim Volunteers (hamentashen baking, Mishloach Manot, Spiel and party). Those will go out this week.

A reminder again that that the Board of Directors group honor is to hold Torah scrolls during Kol Nidre (Sunday evening, Sept, 24) More information about that honor will be forthcoming and Becky Markowitz is helping to coordinate.

#### Selichot:

Our experiment to join the larger Bucks County congregations was a bust. We only had 3 people to the program on Sat. night at 2 stayed for the service (which ended at 11:15 and was far more traditional that what we are accustomed to). Next year we will return to Shir Ami for a program that is more appropriate for our community.

The Torah Mantle changing during Religious School was also mixed. It was nice for the kids who were chosen to help change the mantles, but did not engage others. We will have to rethink how we might bring elements of Selichot into the RS.

But, we live and learn. Better to experiment and come up short than to not try something new at all.

Our HHD Lifelong Learning classes were well attended and folks have spoken highly of them. Many thanks to Rabbi Eric for coordinating.

**RAC-PA:** Seven Shir Ami folks were among the 70-80 Pennsylvanians who joined for our training last week to launch our campaign this year with Cease Fire PA, a gun safety organization lobbying for the Common Agenda to enact common sense gun safety legislation. In the weeks ahead, I will be working with Andee Losben, Essie Cherkin, Barbara Roth and Helen Berman to strategize for our in district meetings with our local reps.

Join us for our study session on Yom Kippur afternoon from 2:00 to 3:00 with other congregations to explore this issue through Jewish texts. I'll be leading with Rabbi Eli Freedman of Rodeph Shalom in Philly along with a former board member for Cease Fire PA who is a member of Beth David in Gladwyne.

**18Doors Rukin Fellowship:** I am looking forward to beginning this fellowship with a three day retreat in October (15-18). I look forward to reporting back next month.

# **Religious School Update**

- It is with deep sadness that I note the Religious School family is mourning the
  passing of Marcy Schaeffer-Allred earlier this month. Marcy taught with us for
  many years, was a friend to all who met her, and will be so deeply missed by her
  students, our teachers, madrichim and myself. Our hearts break for her mom and
  dad, Helen and Larry, her sister Ember, her husband John and their four children
   Erin, Gabby, Nick and Ryan. May Marcy's name be for a blessing today and
  every day.
- 2. Enrollment for the 23-24 Religious School year has exceeded expectations. As of Friday (9/8), 237 students were enrolled in K-10th grades, with an expected 5-10 more student enrolling in the next couple of days. This expectation is based on phone calls, conversations and emails between several families, myself, Jodi Friedman, Phil and others. Our expectation was that 226 students would enroll.
- Our teachers and madrichim (teen teaching assistants) have been meeting throughout the summer and had our Opening Faculty Meeting last Tuesday (9/5). We have an amazing group and I am so proud to be part of this team. I am also proud to announce that we have more madrichim than at any time I can remember. Our teens are truly a special group!
- 4. As I am writing prior to the event, we are incredibly excited for our Opening Day of Religious School, Sunday 9/10. We will meet as a K-5th grade school family from 9-9:30 for an Opening Assembly, followed by a Meet & Greet + Community Connections Event from 9:30-10:45 and conclude with a all school Tefillah/Song Session from 10:45-11:30. Today Rabbah to our teachers, families, madrichim,

- Ellen and the entire Religious School Committee, Ferne, Rabbi, Cantor, Jodi, Jodie, Natalie, Shanika and all who will be there to get our year kicked off!
- 5. The 2023-2024/5784 Religious School year will focus on the idea that learning/ studying about living a Jewish life is infinitely valuable, but only if that learning leads to action. This text will be our guide: R. Tarfon and the Elders were reclining in the upper chamber of the house of Nitza in Lod, when this question was raised: Is study greater, or practice? R. Tarfon answered: Practice is greater. R. Akiba answered saying: Study is greater, for it leads to practice. They answered and said: Study is greater, for it leads to action. (Babylonian Talmud, Kiddushin 40b)
- 6. With this teaching in mind, we asked families to bring some (or all) of the following to be donated on the first day of school/throughout the beginning of our year: a. Non-Non-Perishable items for the Shir Ami food pantry; b. Winter Coats and Feminine Hygiene Products for Mitzvah Circle; c. Children's/Young Adult Books for Tree House Books and/or d. Clothing for JFCS. Fran Held, Director of Mitzvah Circle, will be at Shir Ami and speak to parents/adults on the 10th. Stan and Shelly Cohen will be representing JFCS on the 10th as well. Michael Brix, Executive Director of Tree House Books, will be coming on October 4th.

# **Lifelong Learning (LLL) Update**

- Our three-part series on preparing for the High Holidays, *Hineni: Here I Am*, was well attended and got our Lifelong Learning year off to a wonderful start. Rabbi, Cantor and I each led a session focused on important topics connected to the Days of Awe:
   The concept of Teshuvah, 2. The Kol Nidre declaration, and 3. Looking back on our actions and becoming the people we wish to be in 5784. Attendance was primarily in person with a few joining us on Zoom. All recordings will be posted on the website in the coming weeks.
- 2. On Tuesday October 3rd, I will teach our first Lunch and Learn session of the year in the sukkah (weather permitting). 'Rain, Rain (Don't Go Away)' will look at the idea that in Jewish tradition it is during Sukkot God determines the amount of rainfall for the entire year. #### **SHAFTY Program**

SHAFTY is the Shir Ami Federation of Temple Youth, one of the largest and most exciting youth groups in the region. SHAFTY consists of four groups based on grade level: <a href="Chalutzim">Chalutzim</a> (grades 3 and 4), Bonim (grades 5 and 6), Junior SHAFTY (grades 7 and 8) and Senior SHAFTY (grades 9 thru 12).
