PLEASE READ THE FOLLOWING INFORMATION CAREFULLY:

1. We are pleased to offer food vendors a rate of \$180 to participate in this event. We provide an 8 x 8 foot booth space that includes 2 - 8 ft. tables, WIFI and electricity.
 - a. Vendors must supply your own tablecloths, disposable paper goods, pens, receipt book, any items needed to serve food, keep food warm and an extension cord if using electricity. You may bring “prep” table as long as it fits within your booth space.
 - b. You are responsible for providing **FREE** “bite sized” samples of your food items for a minimum of 500 attendees. **No food product is to be sold.**
 - c. Additional items:
 - i. Additional 8 x 8 foot space is \$90 (includes additional tables).
2. Food Vendors must provide a **menu, signage and enough samples** to last the length of the event. In the event that you run out of samples you **MAY NOT** vacate early. It is your responsibility to promote yourself accordingly.
3. Event is **kosher style** (no mixing of dairy items with meat items, no pork and no shellfish). Food items stated on this contract are the only food allowed. Failure to adhere to this may result in removal of your booth and no refunds.
4. Contracts will be accepted on a first-come first-serve basis and may be subject to refusal due to limiting an abundance of like food items being sold. To ensure the enjoyment of event goers, we will continue to minimize duplication of items.
5. Setup starts at 9:00 am. Please be prepared to unload your items from your car and immediately park your vehicle in the parking lot. Vendors are responsible for transporting any and all materials to their designated booth space. We **do not** have carts available. All tables must be set and items removed from the floor by our 11:30am pre-event inspection time. Breakdown begins at 4:00 pm. All vendors are expected to vacate the premises by 5:00 pm.
6. Booth space fees are non-refundable and non-transferable. No shows forfeit all fees paid. Event will take place **RAIN OR SHINE**. Temple Beth Emet reserves the right to remove any exhibitor for any cause and at any time. No refunds will be issued.

7. Advertising/marketing of event will be handled by both parties including press releases, newspaper listings, Facebook, direct mail and signage in the local community. We expect your business to advertise this event immediately upon executed contract, including sharing our website www.noshfest.org and our Facebook page at www.Facebook.com/NoshFest. This event is open to the public. Both parties agree to continue to advertise up until the day of event.
8. **PROHIBITED ITEMS: All firearms, weapons and any items deemed inappropriate for a family event are strictly prohibited.**
**If a chef's knife is needed for your food service it must be stated in this contract and will be subject to search and onsite security rules.* _____
