

Health and Safety Authorizations-Parent/Guardian Signature Required

Disclosure of Medical Information: I understand that LEFTY is not defined as an entity subject to HIPAA and therefore is not covered by HIPAA regulations concerning patient medical records. I also understand and agree that situations may necessitate that my child's medical information be shared with the event staff and/or event medical staff. I give permission to any Health Care Provider, such as a hospital or physician to share my child's medical information with the event medical staff, for treatment purposes.

Health and Safety: The health history submitted during online registration is correct and complete to my knowledge. The person herein described has permission to engage in all program activities except as noted. I hereby give permission to LEFTY and Temple Isaiah to provide routine health care, and seek emergency medical treatment including ordering x-rays or routine tests. I agree to the release of any records necessary for insurance purposes. I give permission to LEFTY and Temple Isaiah to arrange necessary related transportation for my child. In the event that I cannot be reached in an emergency, I hereby give permission to the physician/health care provider selected by LEFTY and Temple Isaiah to secure and administer treatment, including hospitalization, for the person named above.

I understand that this activity includes the risk of my children contracting a communicable disease including COVID-19 and its variants. I agree that my child will adhere to all the precautionary practices the temple has put in place to minimize this risk. I hold harmless Temple Isaiah should my child become ill.

Update of Health Related Information: I understand that the health history submitted online will be used for future LEFTY and Temple Isaiah events through June 30, 2022. I understand and agree that it is my responsibility to provide LEFTY and Temple Isaiah with any changes, or updated health related information prior to each event.

B'rit Kehillah- Code of Conduct: We understand that part of the LEFTY experience involves activities, group living arrangements, and interactions that may be new to my child. These things come with certain risks and uncertainties beyond what my child may be used to dealing with at home. I am aware of these risks, and I am assuming them on behalf of my child. I realize that no environment is risk free and so I have instructed my child on the importance of abiding by the Code of Conduct. My child and I both agree that he or she is familiar with these rules and will obey them. We further understand that sanctions imposed by the Event Director for violation could include immediate expulsion from the event, at the expense of the parent/guardian.

Event Transportation- I give permission for my child to be driven to and from the event by authorized vehicle (bus or automobile) transportation. I understand that they may not drive to, from, or during the event without written permission from the Event Director. I agree to indemnify and hold harmless Temple Isaiah, their employees, volunteers and members from any harm which may come to my child while driving to or from the event.

Temple Isaiah and LEFTY have my permission to use any recording, or other depiction of (whether by sound, video, photography or other means) or testimonials by (written or verbal) my child or any family member for the purpose of promoting LEFTY.
