 - There is currently a property line issue with some of the gravesites.

7:52 Nominating Committee for 2019-2020 Board – Matti Fromson

 - The clergy now have the ability to control the sound in all spaces and transfer the sound between spaces. Other parts of the system may continue to age out and will need future repair and replacement.
