**PLEASE RETURN THIS FORM BY WEDNESDAY, APRIL 17, 2019**

*Before Pesach it is a requirement to eliminate all chametz (bread products or derivative of bread products) from our possession. Jewish law does allow for chametz, especially and preferably, only in non-breadlike form (e.g., liquor, mixtures, etc) to be sold to a gentile. Arrangements for such a sale may be made through Rabbi Adam Starr using the form below. It is preferable to meet the rabbi in person to appoint him to carry out the sale. Rabbi Starr will be available for this purpose each night following maariv and shacharit on Sunday mornings. If this is not possible, you may mail, email (in .pdf format) or fax to the address(es) shown above. Note: Kitniyot and chametz utensils should not be sold.*

*Rabbi Adam Starr does not accept personal money gifts for this service, which he views as a privilege to perform. He does, however, welcome donations to the Rabbi's Discretionary Fund where a significant portion will be used to help people in need with Pesach expenses, (Ma'ot Chitim) and other charitable needs. Of course, no donation is needed at all to authorize the sale of chametz.*
