Choosing an electricity supplier: How will you decide?

Tuesday March 4 - 7:00 PM

Electricity deregulation is a fact of life for Californians. In the mid-90s Pacific Gas and Electric Company sold off most of its fossil-fuel power plants to other power producing companies and kept its many hydroelectric facilities, its nuclear power plant and the Helms pumped storage facility. The electricity that we use today comes from these sources, plus a mix including wind, solar, small hydro and geo-thermal. In times of need, power is "wheeled-in" from outside of the state. In fact, the electric grid that we all get our power from is interconnected with the 11 western states and parts of Canada.

With the concern that PG&E has not done enough to encourage the development and procurement of renewable sources of power, and looking to take action locally, Sonoma Clean Power (SCP) was formed. SCP intends to



bring a local focus to energy purchases and production. Their program, to be phasedin beginning May 1, 2014, will be offered first to 14,000 business and 6.000 residential customers in the target areas of unincorporated Sonoma County, and the cities of Cotati, Santa Rosa, Sebastopol, Sonoma and Windsor. Over the next 2 years, the remaining 200,000 residential, commercial and agricultural customers will be given that choice.

On Tuesday, March 4th, at 7:00 pm in the CST sanctuary, you will be able to hear a discussion, hosted by the CST Environmenta l Action Committee, regarding this change of electricity suppliers and how it will affect you. The speakers include Geof Syphers, Sonoma Clean Power CEO, and Tom Bottorff, PG&E Senior Vice-President for Regulatory Affairs.


Shomrei Torah Book Discussion

The compelling new novel by Dara Horn, A Guide for the Perplexed, has been selected for the second annual One Bay One Book program, sponsored by Jewish Learningworks, in partnership with synagogues and other Jewish organizations throughout the Greater Bay Area. New Kashrut Policy

Following an extensive examination by the Ritual Committee and recommendation to the Board of Directors for review and discussion, the Board approved a revision to the Synagogue's Kashrut Policy (Jewish dietary law). Long-time members will note, no doubt, that in certain respects we are returning to the Policy that was in effect some time ago. In adopting the new Policy, the Board desired to embrace rules that would be inclusive, balance personal choice with fidelity to Jewish Tradition, and

maximize the opportunity for those that choose to follow Kashrut, and those that do not, to feel comfortable while participating in events where food is served. As a Reform congregation, Shomrei Torah is not required to adopt rules that would comply with the full array of the laws pertaining to Kashrut. But, as is stated in the policy, we "...find value in embracing the spirit of those laws, recognizing both the importance of food and the benefit of the heightened awareness of what we consume, as well as the value of connecting authentically to our Jewish heritage."

With that by way of background, the policy is as follows:

At all Synagogue events, whether held on or off the Temple grounds (including, but not limited to potlucks, Onegs, B'nei Mitzvah, committee meetings, Chavurah events, or full meals), there shall always be a vegetarian option; none of the "Forbidden Foods" can be served; and meat and dairy shall not be served on the same platter (no meat lasagna) but items of meat and dairy can be served if on separate dishes and in separate areas.

Forbidden Foods are all foods, the consumption of which is forbidden by the Torah, such as meat from animals without split hooves or those that do not chew their cud (these include pork, pork products—ham, bacon, lard—bear, rabbit, venison) or shellfish and fish that do not have scales and fins (these include, but are not limited to, shrimp, scallops, oysters, clams, prawns, lobster, shark, monkfish, calamari or catfish).

The Policy applies to all CST sponsored events including those events that take place away from the Temple building. It is hoped that all members will help to enhance observance of our Policy. This means, for example, food served at a member's home at a committee meeting should be in compliance with the Policy. This will allow all of our members to feel comfortable at the "Shomrei Torah Table".

Chai Weekend Marks Rabbi George's 18 Years At CST

April 4, 5 and 6

Shomrei Torah honors Rabbi George Gittleman's 18th year as our rabbi with a series of events April 4-6. Known as Chai Weekend, the event begins with special Erev Shabbat and Shabbat morning services, peaks on Saturday evening with the gala Chai Ball, and concludes on Sunday with a religious school tribute.

Chai is the Hebrew word for the number 18 and, because it is also the word for "life". carries great symbolic and mystical meaning. This year marks 18 years since Rabbi George arrived at Shomrei Torah, in 1996, as its first full-time rabbi.


Shomrei Torah Camping Trip



Pookie

"Young people should pray that when they are old their eyes see, their mouths eat, and their legs walk, for in old age, all powers fail." (Tanchuma Miketz 10)

When I was younger, I felt as though I was my grandmother's favorite. When I was around, it seemed as if I was all that mattered. There was no limit to how many books she would read, or what illnesses I was able to cure with my plastic assortment of tools. She was one of my favorite people and I knew I was definitely hers.

These memories plus so much more make it even harder to visit her today. She was the woman who never sat still: she got her exercise by walking laps in her home, she cooked (not very well) and cleaned and took great care of everyone she loved. She was such an avid reader, she could literally spell any word. And she was strong, not in the 21st century definition but in her definition. She worked outside the home, but she didn't have a high school degree let alone a college or graduate degree. Even though she worked with my grandfather, taking care of her family was the number one priority. She was not a docile, do as she was told female. She argued with my grandfather, nagged him and she probably ruled the roost more than anvone knew.

It's so sad that all of this is gone. My grandmother still lives at my mother's home, where she has lived since my



grandfather died 13 years ago. Yet she is merely a shell of a person I once knew. She can't see well enough to read or watch TV. She gets lost in conversations, often reverting back to years ago. She never recognizes my sister, who really is her favorite person in the whole world. She is completely bed ridden, with around the clock care and hospice that comes three times a week to manage her pain. Going into her room to speak with her or sit there while someone feeds her spoonfuls of food is excruciating.

As my entire family all piled into my mother's home in Houston in December, we were all keenly aware of the severity of the situation. The only person who didn't have the vocabulary to discuss the sorrow was my son. At threeand-a-half. Micah would walk into Pookie's room multiple times a day, to kiss her and talk with her (even though she couldn't hear a word he was saying.) She has always been a magnet to young kids, and Micah truly loves her no matter what her state is. Since Pookie told him she would be better soon and walking around, he asked everyday when she was going to get up.

With so much talk about impending birth and infancy, Micah has drawn conclusions concerning the cyclicality of life and how my elderly grandmother is very similar to an infant that needs constant care and supervision. Now home, Micah is still talking about Pookie all the time. Even he was disturbed with her state, though it comes across as questions and observations rather than tears and sorrow.

As medical advances allow people to live longer, many of us are going through the turmoil of watching our loved ones fade away. The sandwich generation is constantly tested as they care for their children and parents simultaneously. I only had to face this reality head on for a short duration. It only remains in my thoughts and prayers, while my mother and sister are there day in and day out.

It is not surprising that our tradition has true words of relevancy for our time. We should all pray that, as we age, all of our faculties continue to work; seeing the decline in our aging loved ones causes us to face our own mortality in sometimes an uncomfortable way. The act of caring for them now brings comfort in thinking that there will be someone there to do the same for us.

Rabbi George and I are always available to help anyone through their difficulties adjusting to the changes, dealing with the guilt and logistics of parents that are far away, planning for the future, explaining the end of life to small children and supporting seniors who are having trouble accepting help.

Notes from the URJ Biennial

In mid-December a delegation of Shomrei Torah members, clergy and the executive director

attended the Union for Reform Judaism's Biennial convention in San Diego. Being in one location with 5,000 Reform Jews from all over the United States and Canada was awesome and inspiring. We experienced four days of learning, praying, singing, dancing, and schmoozing.

One of the opening prayer services was co-led by our own



Cantor David Frommer. I took great pride in hearing from one person after another who was as impressed by Cantor David as we are! It was a beautiful beginning to a very full experience. We had the opportunity to experience different paths to prayer

including morning services ranging from "Yoga Shalom: A Shacharit Embodiment of Prayer" to a visual service with no prayerbook to an Israeliled service integrating prayer with pop music and poetry. On Saturday morning, Rabbi Jacobs teamed with Rabbi (and Cantor) Angela Buchdahl of New York's Central Synagogue to lead a Shabbat service with singing, dancing, and "Storahtelling," showcasing how far our movement has moved away from the Germanic, High Church-style Reform that was popular in the mid-20th century.

The Biennial's predominant theme matched beautifully with one of our priorities at Shomrei Torah: engagement. URJ President Rabbi Rick Jacobs challenged congregations to practice "audacious hospitality" by being as welcoming as possible to intermarried families, unengaged Jews, and to reshape youth engagement strategies. Ron Wolfson, a professor of education at American Jewish University challenges us to be as welcoming as possible to all who enter our doors.

In addition to engagement, there were multiple sessions devoted

to the challenges facing the Reform movement and much discussion based on the Pew Research Study. Announcements were made that the Ruderman Family Foundation, which focuses on disabled people, is committing \$600,000 over the next three years to help make Reform synagogues more disabled-friendly. And the Harold Grinspoon Foundation is offering URJ congregations up to \$900,000 in support over the next five years to help bring PJ Library, a Grinspoon program that delivers free Jewish-themed books every month to more than 126,000 families, to small

communities that don't have access to this resource.

The union is also strengthening its relationship with the Hebrew Union College-Jewish Institute of Religion, our movement's rabbinical school and academic center, in part by moving most of the URJ youth-programming professionals to the HUC campus in Manhattan.

It certainly is an exciting time for the Reform movement and Congregation Shomrei Torah.

The solution -- There are safer ways to dispose of


them. For example, several Sonoma County restaurants accept clean, liquid vegetable oil that's free of solids, meat scraps or water. Among them are Betty's English Fish and Chips in Santa Rosa, Big John's Market in Healdsburg, and Black Bear Diner in Sonoma. In addition, Yokayo Biofuels, a licensed grease collection center in Ukiah, collects used oils and processes them into biodiesel.

The NBOP is a broad coalition of faith-based and community groups. 


