

CERTIFICATE OF INCORPORATION

CONGREGATION SONS OF ISRAEL OF OSSINING, NEW YORK

Pursuant to Article 10 of the Religious Corporations Law,

We, the undersigned, all being persons of full age, of whom at least two thirds are citizens of the United States, and at least one a resident of the State of New York, for the purpose of incorporating an unincorporated Jewish Congregation, pursuant to Article 10 of the Religious Corporations Law, hereby certify as follows:

1. A meeting of the CONGREGATION SONS OF ISRAEL OF OSSINING, NEW YORK, an unincorporated Jewish Congregation, was duly called and held in conformity with the aforesaid Article of the Religious Corporations Law, at Waller Avenue, Ossining, New York, on the 4th day of May, 1944, at which meeting a majority of the duly qualified voters of said Congregation, being at least six (6) in number, were present.

2. At said meeting, EMANUEL LAUTERBACH, one of the subscribers hereto, was presiding officer, and PHILIP KLEINMAN and MORRIS SCHLEIFER, the other subscribers hereto, were present and voted thereat.

3. At said meeting it was duly decided that said Congregation should become incorporated.

4. The name of the proposed corporation, as decided upon at said meeting, is to be CONGREGATION SONS OF ISRAEL OF OSSINING, NEW YORK.

5. The number of Trustees thereof shall be (3) three.

6. The names of the persons elected as Trustees and the terms of office for which they were respectively elected are as follows:

MENDEL ZORN, to hold office until the first annual election of Trustees thereafter; HARRY WHITE, to hold office until the second annual election thereafter; and HYMAN BROWN, to hold office until the third annual election thereafter.

7. The principal place of worship of said Congregation is located in the Village of Ossining, County of Westchester, and State of New York.
