From Strength to Strength - President's Message

January 10, 2014

eloquently reminded us at the High Holidays.

Congregation Temple Israel is strong. In that position, we have had and will continue to have choices. As I tell my children frequently, choices can be very challenging, but that sure beats the alternative: no choices. Having choices means we get to consider, influence, and determine our own future. What can be more exciting – and difficult? Sometimes, exercising choice requires a bit of "holy chutzpah," but luckily, we at Temple Israel have always had that, as Rabbi Feder so

This past year, 2013, has been a perfect example. Because of our strength, Congregation Temple Israel had the opportunity to evaluate whether a merger with Congregation Shaare Emeth was our best future. The process of evaluation was exciting . . . and challenging. As you well know, both congregations concluded that a merger was **not** in our best interests, but in the process, Temple Israel learned about what makes us strong and what could be strengthened further. Those lessons fueled our recent update of Temple Israel's strategic plan.

Simultaneously with merger discussions, we faced another decision. This beautiful, but very large building is also in need of "strengthening." Is this the building to carry us into the future? We decided that, regardless of the outcome of the merger conversations, we needed to replace the roof over our Gall Family Sanctuary and Isserman Auditorium. Fortunately, the project has come in under budget, which presented us with another decision point. Should we use this opportunity to engage in more "holy chutzpah" and renovate the interior of our sanctuary and social spaces? You told us what made the JCC space during the High Holidays appealing to you. It was new, different, fresh, bright, and felt more communal. Our renovation will mean that in addition to being dry, our worship and social spaces will be warmer, more welcoming, and brighter, with improved sound and more flexible and intimate spaces.

Making this aspect of our Rabbis' vision and our strategic plan a reality will make Temple Israel even stronger. It will improve the worship and social experience for our members and will help attract new members. It will give us spaces conducive to worship, learning and community. Please plan to join us late this summer when we re-dedicate our remodeled sanctuary, which will enhance and "strengthen" Temple Israel.

What else does the future of Temple Israel hold? Who knows? I can tell you that our congregation will continue to be strong and we will continue to have choices. I believe there are two keys to our future: We must have "holy chutzpah" and we must have strong leaders. So let me comment for a moment about your leaders.

When David Weinstein first approached me about becoming President of Congregation Temple Israel, I declined. When he approached me again, I declined again. When he approached me a third time ("Third time is the charm," right?), I hesitated ... and he was encouraged! Obviously, I ultimately agreed to become President, but you might wonder why I was hesitant. In retrospect, I was unsure if I had the strength for the job, if I could live up to my amazing predecessors, and if I would know how to help Temple Israel along its journey. Whether I actually met these expectations is for you to judge, but I am happy that I finally agreed to serve our congregation in this way.

Last year, I started looking for a President-Elect, someone who could guide Temple Israel further along its path. I have no doubt that I identified a strong leader in Dee Mogerman. She has the heart, the brains, and the strength to carry us into the future. Be kind to Dee – this is a hard job; and be supportive of her, for no matter how strong a President is, your support is critical.

This brings me to those who provided my support and strength these past three years. First – all of you, our wonderful Temple Israel members. Thank you for attending Temple events and services, for assisting our congregation through your donations of volunteer time and financial resources, for reading my e-mails and letters and our monthly *Dateline* and weekly e-newsletters. Without you, Temple Israel would not be a "family of families."

Second, the Temple Israel Board of Trustees and Officers. We are so fortunate to have so many smart, caring, and generous congregants serving as Officers and as Board Trustees. During the past three years we have had long meetings, short meetings, contentious meetings, and smooth-flowing meetings... but NEVER boring meetings. At our meetings, questions are asked and leaders and staff are challenged. As a result, the very best decisions are made. I also want to specifically thank David Weinstein, who has set the bar very high for future Immediate Past Presidents.

Third, our Rabbis and staff. Our Rabbis and staff are our congregation's greatest strength. Our Rabbis and staff work hard to connect with all of our members – from our children and teens, our young adults and parents, our adult learners and worshippers, to our most senior of seniors. It has been humbling to serve as President with a new Senior Rabbi, the youngest ever in a congregation our size, and a new Rabbinic team, Temple Israel's first husband-wife team and one of very few in the country. I have gotten strength from them, and I hope they have also received strength from me. Our congregation will continue to be strengthened with Dee as our new President, working hand-in-hand with our Rabbis.

Finally, whatever strength I personally have comes from my family. My family set the example of getting strength and satisfaction from giving back and doing right. My goal was to set that example for my children and step-children. L'dor v'dor – from generation to generation. I simply could not have served as President without my husband, Jim, who lived with me through every single aspect of this Presidency, often without knowing many, or even any, details.

He was and is my strength, and I thank him for that.

So here we are – with merger discussions behind us, under a dry roof, with a thriving preschool, a refreshed strategic plan, and an improved financial picture. No more waiting to see if we merge with another congregation or leave this site. We are here. So what does 2014 hold for us? I only know that that 2014 will be exciting – and challenging – and a year in which Temple Israel continues to exert "holy *chutzpah*" and grow stronger.

Thank you for allowing me to be part of Temple Israel's journey from strength to strength.

Mission Statement

We are an adult crafting group that strives to provide a casual, fun, supportive, and stimulating environment for creativity and friendship to thrive. We pursue projects that support, benefit, and engage our TI community, as well as local charities and Jewish, U.S., and Israeli military personnel. In addition to working on charity projects, members are also free to work on personal projects. We welcome adults of all ages with a wide range of crafting interests and skill levels. Beginners are encouraged to come and need not be shy. We love to teach beginners!

We also happily accepted donations of handcrafted items from people who prefer to work at home.

Our group meets in The Gathering Place at the Temple twice a month - on Sunday mornings from 9:30-11:45 a.m. when Religious School is in session, and on Tuesdays evenings from 7:00-9:00 p.m. when there is no school.

2012 - 2013 Projects

This year, some of our time has been spent knitting and crocheting items, including tiny hats and booties for preemies that will be donated to Newborns In Need, and cuddly teddy bears for Precious Pals, a program for first responders to accidents, fires, etc., whenever children are involved and have been traumatized or injured and are in need of comforting.

We had a booth at the Temple's Purim Carnival for the second year in a row. We provided cute paper plate crowns for kids to make and decorate. Whatever proceeds were made went to support TIFTY.

We operated three stations at the Temple's Mitzvah Day on May 5, 2013:

- *Collage Note Cards* We helped congregants create 68 note cards. Cards were given to the Temple's Tikkun Olam Committee to distribute to congregants in need of good cheer and to The Card Care Connection, a charity that sends handmade note cards to cancer patients.
- Origami Station Our crafting crew taught adults and children how to make origami birds and fish for hanging mobiles. During several of our subsequent crafting meetings, we created three beautiful mobiles. One has been donated to the St. Louis Crisis Nursery. We are still looking for homes for the other two.
- Rainbow Mural Everyone attending Mitzvah Day was invited to add their handprints to a very large rainbow mural.

 This mural was donated to Parc Provence to help residents "think happy thoughts."

This fall, our group requested donations of buttons from TI congregants. We received several donations in response. The buttons will be used in future projects. In addition to facilitating the crafting meetings this past year, I taught a *Tallit* Making class with Rabbi Michael Alper. The six participants in the class each created a beautiful one-of-a-kind prayer shawl. Everyone found the class to be enjoyable, fun, informative, and meaningful.

Deutsch Early Childhood Center and Rabbi Mark and Carol Shook Camp Committee

DECC Mission Statement

The Deutsch Early Childhood Center of Congregation Temple Israel builds relationships that foster each child's social, emotional, intellectual and physical growth in a safe and nurturing Jewish community.

The DECC Committee was created by the Board of Trustees in 2007 to oversee the Deutsch Early Childhood Center. Its purpose is to work with the DECC Director to set policy for and to promote the preschool and camps of Temple Israel. In turn, the DECC Parent Committee is then free to focus on its primary roles of fundraising, creating a social community, and coordinating room parents within the school.

The 2013-14 school year marks Leslie Wolf's fifth year as director of the Deutsch Early Childhood Center. Enrollment has increased to 190 students. Although it was determined by the committee last year that the enrollment capacity should be at 180, the preschool is utilizing space on the religious school floor to accommodate special classes such as art, music and Judaics. This has freed up space on the first floor and lower level for 13 classrooms within the preschool, one being a new class for 15-24 month-old children.

Enrollment trends for the past five years:

- 42 students in 2009-2010
- 103 students in 2010-2011
- 145 students in 2011-2012
- 185 students in 2012-2013
- 190 students in 2013-2014

Highlights from the DECC 2013 school year:

- The Brooke Fund, which provided funds for the family of one of our DECC teachers who was undergoing treatment from a serious medical condition, received \$1,700 in donations in January 2013 and \$6,000 in fall 2013. Parents were asked to contribute to this fund in lieu of the school's Annual Giving appeal to support scholarships for DECC.
- The school's Book Fair is now being held at Barnes and Noble, enabling DECC to receive a portion of the proceeds in cash rather than in books. The fair has been well attended the past two years and has provided a social, community-building activity in addition to fundraising. The Book Fair raised \$600.
- DECC's annual big fundraising event in spring 2013 was a Casino Night held at Temple Israel. The event grossed more than \$20,000. These funds are being used to update the nature center at the school, which provides students with a hands-on, experiential mode of learning about science and nature. The funds are also being used to purchase ongoing needed teacher tools and toys.
- Before and After school care continues to be offered by DECC. Care is available from 7:00 a.m. 6:00 p.m.

- DECC continues to offer flexible programming for all students. Parents have the opportunity to send their child to school as many days and hours as they wish, regardless of their child's age.
- DECC provides quality, engaging, high-interest activities such as Art, Pre-K Theater, Little Warriors Martial Arts, Science and Cooking, Music, and Hi NRG Gymnastics through its enrichment program from 1:15-3:15 p.m.
- DECC continues to use the Project Construct curriculum in all classrooms.
- Several new teachers have been hired to address the growing population of DECC.
- The Dial 4 Developmental Screenings are administered to all students ages 3 and older. This screening provides valuable information about each student's social, academic, motor, speech and language development. Each child's parents are invited to a conference with Leslie Wolf to discuss the results of the screening.
- Tot Shabbat, held on the first Friday evening of each month, is promoted and well attended by DECC families. This program gives families a sense of Temple life and worship at Temple Israel, as well as an opportunity to socialize and enjoy Shabbat dinner with other school families.
- DECC is currently undergoing the re-accreditation process.
- Leslie Wolf has revitalized the Shabbat Parent program, which affords parents or other special loved ones the opportunity to visit their student's class and be a part of the DECC community for the Friday morning Shabbat celebration.
- A parent's night was held at Ruth's Chris Steak House in the fall. This event was well attended and enjoyed by many parents.

An electronic survey was e-mailed to all DECC parents in May 2013.
 The results were extremely favorable, with the vast majority of parents reporting being pleased with staff, curriculum, warmth of environment, and opportunities to get involved within the DECC community.

DECC Parent Committee

The Deutsch Early Childhood Center continues to flourish and is currently at capacity as far as the number of students.

In regards to fundraising in 2013, the Parents Committee hosted a Casino Night at Temple Israel in April that was a huge success. The event was attended by close to 100 people and grossed more than \$20,000. The night consisted of music, black jack, poker, roulette, a silent auction and a raffle for a two-night stay in Miami with airfare.

It was decided in the 2012-13 school year that we would do away with smaller fundraisers and focus on one big event each year. With this in mind, we had our first fall annual giving appeal in late 2012 and raised more than \$6,469, which is twice what we anticipated! Each family was asked to donate a minimum of \$18 per student, with different incentives for donors who gave more. Last year's fundraiser, Art Stamps, raised slightly more than \$800 and was significantly more work for parents. Funds raised from the 2012-13 school year went to help build the new DECC Nature Center and to replace flooring in some of the classrooms.

This fall year we held our school book fair at Barnes and Noble instead of having a Scholastic Book fair at DECC. Barnes and Noble donated 10 percent of all proceeds from that week to our school, which amounted to \$600 (more than we made through the Scholastic Fair). The book fair also served as a great community building event. We had crafts and story time for the students on Saturday morning and a Moms' Night during the week that featured author Curtis Sittenfeld discussing her new book, *Sisterland*. Parents and staff enjoyed the new format and thought that it worked well.

We have decided that because our school has grown so much, we would have one parent get together each fall and then smaller events by classroom. In February, we hosted a Moms' Night Out at Immerse, which more than 40 moms attended. Each parent was asked to donate a bottle of wine that was used at our Spring event. We had a school-wide Moms' Night out this past September at Ruth's Chris, which was a fun night for all. We had a turnout of more than 50 moms for this event. Room parents were encouraged to organize class nights out later in the fall, which have been well attended.

Throughout the year, our Teacher Appreciation Committee provides a special breakfast each month for the teachers to show our continued appreciation for them. All parents are asked to help bake and pick up food for these fun, themed breakfasts. The Teacher Appreciation Committee and Parent Committee Chairs also work together to provide breakfast and lunch for the teachers and staff during the December and May parent-teacher conferences.

Room Parents help organize class parties for Chanukah and Purim. We have also resurrected the weekly class Shabbat Parent, which has been well received. Each class asks parents to sign up at least once per semester to come into their child's class on Shabbat and read stories and help say the prayers. All parents are invited to attend the weekly Friday morning DECC Shabbat service with the Rabbis.

Evening Tot Shabbats are held on the first Friday of each month and are open to all families with preschool-age children. Most Tot Shabbats include snacks and/or dinner, wine, and activities.

Development Committee

The roof construction project, our High Holy Day services at the JCC, and the merger conversations with Shaare Emeth all presented challenges to our development and special event fundraising efforts in 2013.

Our amazing 125th anniversary year of celebration, which concluded with our Birthday Bash in November 2012, raised nearly \$144,000 for the Temple, far exceeding our goal of \$125,000. With the Birthday Bash taking place so close to year-end, our Temple leadership elected not to hold a major fundraising event in the summer of 2013, as had been our custom. We were fortunate to receive a very generous anonymous gift in 2013 to enable us to achieve our budgeted development goal.

With roof construction commencing over the summer and the High Holy Days arriving right after Labor Day in September, we focused on enhancing our annual High Holy Day Appeal to include a Patron campaign to help cover the cost of conducting our worship services at the JCC. Congregants responded generously and enthusiastically with donations totaling \$46,863.

In January 2013 we introduced a new ongoing fundraiser, the Temple Israel Wish List. In each month's *Dateline* newsletter and on our website we highlight opportunities for congregants to fund specific needs of the Temple. We have received nine donations in 2013 totaling \$4,340 to fund two Confirmation scholarships, two years of emergency phone service for our rabbis, a youth group event chaperone, a Pre-Oneg Shabbat, our Kol Nidre cellist, one year of Temple gifts to our B'nai Mitzvah students, and one month of Internet service.

Another of our ongoing fundraisers is our Temple Israel scrip program. By purchasing gift cards to Dierbergs, Whole Foods, and St. Louis Bread Company, and by obtaining a free eScrip community card for Schnucks, congregants and friends of Temple Israel can support the Temple by simply doing their regular shopping. Congregants can place a standing monthly order for gift cards that will be mailed to them the first week of each month, with the cost automatically charged to the credit card or bank account of their choice. Cards can also be purchased online, by mail, or by dropping by the Temple office during business hours.

Other ongoing ways the Temple raises funds are through the sale of "leaves" on the *Eyts Simcha* (Celebration Tree) in honor of special occasions and family milestones such as birthdays, weddings, anniversaries, B'nai Mitzvah, etc. and through the establishment of new Perpetual Memorial and Wall of Honor memorial dedications.

Facilities Committee

The major work on the facility this year was the construction of a new roof over the Gall Family Sanctuary and Isserman Auditorium. I am pleased to report that the project came in on schedule and under budget. This, along with additional fundraising, will allow us to remodel the interior of both of these spaces during the coming year.

We experienced a significant loss from sewer back-ups in both the main and school building basements resulting from overcharged storm sewers and the creek on our property during an unusually severe storm. We were able to cover our losses through insurance and have finished replacing damaged areas in both facilities.

During the year, the preschool again expanded to meet growing enrollments. This required a moderate investment in lighting, flooring, air conditioning and life safety improvements in these spaces.

Unfortunately, our aging facility continues to experience various mechanical and system failures in addition to normal wear and tear. The Board of Trustees completed a revised strategic plan this past year which requires, in part, that we inventory all facility areas needing attention and set priorities for replacements and improvements in the next three to five years.





Human Resources Committee

The Human Resources Committee's goals and objectives include developing and implementing strategy, plans and programs to attract, motivate, develop and retain the best people to further Congregation Temple Israel's mission, as well as to reduce the risk of employment litigation and protect our reputation in the community.

2013 Accomplishments:

- Provided legal counsel, recommended modified employment practices, and reviewed Patient Protection and Affordable Care Act (PPACA) and its potential effect on Temple Israel.
- Ensured job descriptions and the organizational chart are updated to reflect changes.
- Followed up with Eli Montague regarding completion of annual performance reviews for all full time employees.
- Continued to ensure the current Employee Handbook and Supervisor Handbook are updated to reflect necessary changes.

Investment Committee

This has been a very productive year for the Temple Israel Investment Committee. We successfully adopted and implemented a Short Term Investment Policy and we have amended our Long Term Investment Policy to allow for a higher allocation to equities. In 2013, the Temple's endowment was positioned for growth, and I am pleased to report to our members that the Endowment's returns exceeded our objectives, and those positive investment returns have contributed to the Temple's budget and construction projects.

As 2013 comes to a close, the Endowment account is up more than 12 percent year-to-date through November. Most of the gains occurred in the first and third quarter of the year with the portfolio up 4.5 and 4.65 percent respectively. In the coming year we are again positioned for growth in the Endowment from the equity markets. We will continue to review the Long Term Investment Policy to ensure that the Endowment investments are aligned with the mission of Temple Israel.

Legal Committee

The activities of the legal committee for this past year have been primarily the review, revision and approval of various contracts of a substantial nature, which the congregation was considering. These include contracts for the roof repairs, rentals for the High Holy Day services, and various Temple programs. Robert Epstein handled the construction contracts, an area in which he specializes. Burt Garland, Jr. assumed responsibility for employment issues. The committee did some preliminary legal research concerning the possible merger, and conferred with attorneys for Shaare Emeth, but this activity was aborted.

The congregation is involved in a surprising number of contracts from month to month, and Eli Montague, our executive director, is very meticulous about clearing legal issues with our committee.

New Mt. Sinai Cemetery Association

Temple Israel co-owns New Mt. Sinai Cemetery along with Congregations B'nai El and Shaare Emeth. All members of Temple Israel are also members of the New Mt. Sinai Cemetery Association. New Mt. Sinai is located just minutes from the Temple. The cemetery is the final resting place for more than 11,000 people. New Mt. Sinai offers in-ground interment and is the only Jewish cemetery in St. Louis to offer a Community Mausoleum with both crypts for caskets and niches for cremated remains. New Mt. Sinai is the only Jewish cemetery in this area listed on the National Register of Historic Places.

Temple Israel members receive significant discounts on pre-need purchases, and the Temple also receives a percentage of all sales of cemetery property to its members. We received more than \$1,100 in 2013. New Mt. Sinai permits the burial of non-Jewish family members and the cemetery also offers burial or entombment of cremated remains. The Community Mausoleum is available for funeral services or memorial services. Each year, a moving Memorial Service is held in the Mausoleum during the High Holy Days recalling those who passed away and were buried at New Mt. Sinai in the preceding year.

New Mt. Sinai has fared well in 2013. Burials were up significantly from the previous year, and investment portfolios increased tremendously over the course of the year. Property sales were sluggish early in the year, so we marketed the cemetery – not only to our owner congregations, but to the entire Jewish community. A promotion in the last quarter of the year resulted in a rush of sales at year-end. We conducted our annual Memorial Day ceremonies with Cub Scouts and Boy Scouts honoring all the veterans interred in the cemetery and our annual High Holy Days Memorial Service in the mausoleum. The moving service included meditative texts as well as vocal and instrumental music.

Treasurer's Report - December 2013

The Temple continues to remain financially sound with continuing members, 934 in 2013 (as of October) and 948 in 2012, consistent dues income, fund raising results meeting budget, controlled expenses, and a stable bottom line. Net dues income is projected to be similar to budget and prior year. Revenue would be stronger if more Temple members were not paying below standard level dues. My message last year is still relevant and worth repeating so here it is: "We urge all members to contribute as much as they can to lessen the burden on those members paying standard dues or above. We need to be mindful that the Temple and its resources are available all year round, regardless of how often we avail ourselves of them. It is our communal obligation, and truly a *mitzvah* to support this strong Jewish place of worship and to ensure that we can continue to welcome all who seek to belong to our Temple regardless of ability to pay."

We project to end 2013 with a small loss, which is consistent with our 2013 budget and compares to a \$136,000 surplus for 2012. These results are attributable to increased tuition at the Deutsch Early Childhood Center, with corresponding increased expenses and stable income and expenses in all other categories. Consistency with level income and expenses is the 2013 theme, which is a positive message to share.

In recognition of our Temple's staff's hard work and dedication, our 2013 results include the remaining small salary increase that began in mid-2012 and continued in 2013.

At the Board's direction, to formalize the inter-fund borrowings, \$813,454 was recorded as the remaining loan balance due to the endowments from the general fund as of 2013. There is a receivable and corresponding liability reflected on the Temple's balance sheet.

It is with pleasure that I present this report as I conclude many years of serving as your Treasurer. My term(s) as Treasurer end in 2013 but my efforts in support of the Temple have only just begun. I am leaving our well-managed finances in capable hands.

Worship Experience Committee

Over the summer the Congregation started using *Mishkan T'filah*, the Shabbat prayer book of the Union for Reform Judaism. The choir was well received and many commented that the singing added a special spiritual component and was a meaningful aspect of the holidays.

Youth Activities Committee

2013 was a busy year for our youth groups and committee.

Youth Education Committee

The second half of our 2012-13 school year was full of energy and events. We completed the first year of our partnership with the Institute of the Southern Jewish Life (ISJL), utilizing their unique spiraled curriculum to give our students a more complete Jewish background. Students participated in Tu B'Shevat seders, chocolate seders for Passover, an Israeli street fair in honor of Israel's 65th birthday, and a collaborative program with the Religious School students at Congregation Shaare Emeth. The school year ended with the annual Mitzvah Day program, where each grade participated in a social justice project to benefit the community.

With one year of our ISJL partnership under our belt, this fall we were able to implement many changes to enhance the curriculum. We have a new ISJL Education Fellow, Sam Kahan, who has brought a wealth of creativity and knowledge and has helped us tweak the program to work even better for us.

We have enhanced our Hebrew program by implementing an online component. Students in grades 2-6 are now using the Behrman House Online Learning Center (OLC), a private and secure online educational platform that provides a safe way to support learning outside of the classroom.

This school year we also introduced a new 7th grade program. Students attend class on Tuesday evenings rather than Sunday mornings. Our program is designed to foster a sense of community among our students and to give them an opportunity to explore Judaism in ways that are most appropriate and relevant for their development and enjoyment. Rabbi Alper is teaching both 6th and 7th grades this year to strengthen the relationships he is building with these pre-B'nai Mitzvah students. Our hope is that this will lead to greater retention rates for our post-B'nai Mitzvah students.

As we continue to refine our curriculum, teaching positions, and activities, the energy has become more evident every week. We look forward to the second half of the 2013-14 school year and beyond with eager anticipation of what is possible for our Religious and Hebrew Schools.
