# RITUAL:

We would like to sell photographs in the lobby from the Days of Awe. A link will be provided to Bill to contact each photographer to get permission to sell the picture and make sure it is not copywrited, Bill volunteered to be in charge of this event.

Alicia attended the security grant training last week. Money will be used to replace the exit doors in the Pavillion and Talmud Torah area. Cameras will be installed by the Talmud Torah and Preschool doors and bollards will be placed by the main doors into the building.

Alicia advises the board of the staffing positions and needs for additional personnel.

### **NEW BUSINESS:**

# FACILITIES:

The Kol Nidre food drive filled four bins plus the blue bin in the lobby. The food is donated to Nourish, which helps the working poor.

Eileen says the Torah Fund Tea is set for November 2 at the Spicery in Glendale.

Eileen also has 20 tickets for the June 30 production of <u>Fiddler on the Roof</u> at the Phoenix Theater.

Other community engagement activities and adult education are as stated on the agenda.
