The Endowment Committee will pay \$160,000 toward the cost of a new roof per the estimate from RENCO Roofing or almost all of the cost leaving Beth El to pay \$1,516 plus any necessary plywood.

Eileen moves and Brad seconds to accept the estimate from RENCO Roofing in the amount of \$161,516 as set forth in the proposal dated November 13, 2023, prepared by Bron Smith with proposal #354-TPO Retrofit.

Beth El's portion of the cost of the new roof will come from the savings account.

It is agreed to have Bill Tuttle and/or Danny Witenstein go through the contract and contact Bron or RENCO Roofing for any questions.. Bill seconds this addition.

We need to make sure that the walkways are included and that all questions are clarified. If Bill and/or Danny feel satisfied with the answers, Beth El will go ahead with the contract; if not, they are to bring the questions back to the Board.

Kim calls for the vote.

The motion is passed unanimously.

SECURITY UPDATE:

The Preschool is joining with Torah Day School to share a security guard. We now have security on Sundays at least through December 31 of this year.

Ben Cooper relayed to Audrey that he needs more volunteers for security duties.

Barbara is working on a proposal for a security grant. These are State funds. Alicia will check into this further.

Alicia is getting a third bid, as required by the grant, on security cameras for the Preschool.
