If paid by the end of the first year of membership: \$2,624

**Junior Family** (both under 31), Obligation deferred until one spouse attains age 31

**Junior Individual** (under 31), Obligation deferred until age 31

## Payment Schedule:

Unless otherwise agreed to with the Executive Director: 100% Religious School Training by September 1; 50% Membership by September 1; 25% Membership by January 1; 25% Membership by April 1; 25% Annual Building Maintenance Fund paid each quarter.
