Our Reopening Task Force has recommended extended safety precautions for the High Holy Day services, including implementing some social distancing in our seating.

In order to accommodate this recommendation, we need your help. We need to know if you plan to stream or attend services in person. If you are planning on attending services in-person we need to know how many seats you would be using. This is especially important for those with permanent sanctuary seats, since those seats would be empty if you are planning to join us via live stream.

If you are planning to join us by live stream, we will have Machzors available to loan out again as we had last year, and we ask that you let us know in advance if you need them.

We ask that you please email or call the office with whether you are attending High Holy Day services in-person (and how many) or whether you are taking advantage of the live stream (and how many Machzors you need to borrow) **by Thursday August 26.**

As always, we make these recommendations in an abundance of caution, primarily for your own protection.
