Seaside Enters 2024 with a New Board and New Committee Chairs

Seaside's new 2024 Board met on January 21 for the first time. During the meeting, the Board announced new committee chairs.

All nine Board members attended, including newly elected members Peter Zoll and Shelley Grabel, who will serve as at-large members. Both Peter and Shelley were officially welcomed.

The executive committee remained the same as it was in 2023: President Lawrence Krevor; Executive Vice President David Herschler, just elected to a second term on the Board; Vice President of Programs Susan Aaronson; Treasurer Howie Hochman; and Secretary Susan Towers.

2024 Brings Hope and Challenges to the Jewish Community

Seaside Jewish Community looks forward to a dynamic year as membership continues to grow and ideas, activities, and energy builds.

At the same time, our thoughts continue to be with Israel as we pray for peace in the Middle East and for a safe and secure future for Israel and our people. Seaside members have shown their support in many ways, including generously donating to the Jewish Federation of Delaware's "Stand With Israel" emergency fund, and also volunteering in Israel in non-fighting capacities.

"Seaside is entering the new year with a strategic planning initiative, a balanced budget, and a membership that is supportive of both the Jewish community and the overall community at large," says congregation President Lawrence Krevor.

The Strategic Planning initiative, already underway, is based on a Brandeis University study last year that revealed a surprisingly large Jewish population in southern Delaware. The study was undertaken in collaboration with the Jewish Federation of Delaware, a Wilmington-based organization of synagogues and Jewish entities throughout the state.

Seaside's strategic plan will look at how to hone Seaside's role in supporting its members, Sussex County's growing Jewish population, and people in need in the larger community. Seaside members will have opportunities to participate in this initiative so watch the eblast for details.

"We at Seaside see ourselves as a part of the overall southern Delaware community," Krevor says, pointing

out that Seaside members have long been involved in charitable and community services that help local nonprofits and people in need.

Each year, Seaside members participate in interfaith food, clothing and other programs geared toward helping the local population. Seaside itself donates directly to nearly 30 local-area nonprofits. In 2023, those donations totaled more than \$11,000.

"We are part of a large and diverse community here in southern Delaware, and work hard to make life better for all," Krevor says.

At the same time, members plan all kinds of social activities and programs, in addition to worship and holiday celebrations led by Rabbi Julie H. Danan and supported by an active worship committee.

Seaside's religious school and youth activities also continue to expand.

Seaside's book group not only draws book-loving congregants to its meetings, but often partners with the Lewes Public Library and with the Browseabout bookstore in Rehoboth Beach to present authors for popular public discussions of their books.

For the third year in a row, Seaside will host a summer concert program. This year the artist will be American folk singer-songwriter John McCutcheon, who will perform on July 21 at Epworth United Methodist Church in Rehoboth Beach. We anticipate this concert will be another popular event that brings people together from throughout the coastal Delaware community.

"We remain dedicated to meeting the worship and spiritual needs of our members, and to continuing our role within the community at large. We thank all of those who have supported us following the Hamas attack on Israel on Oct 7. And we appreciate the support and kindness expressed by so many toward Seaside and our members," Krevor said.

Sharing Shabbat, a tradition and favorite program of Seaside's, will be held on Friday, **March 29**. Since March 29 is the fifth Friday of the month, no formal Shabbat service will be conducted that evening.

Seaside prepares for the future through its Strategic Planning Committee

The Strategic Planning Committee has begun its work. Having determined that engaging an outside consultant would be beneficial, the committee reached out to their contacts for suggestions. Leslie Newman and Marilyn Feldman, Committee Co-chairs, then interviewed five individuals or firms to determine who would be a good fit. These groups were based in Boston, Philadelphia, and surrounding areas. Conversations determined attitudes, approaches, creativity, experience, and cost. We learned quite a bit and used these perspectives to evaluate the conversations.

The co-chairs prepared and submitted a report to the Committee summarizing the consultant candidates and providing the pros and cons of each for Seaside. The Committee considered each of them and recommended engaging

the Delaware Association for Non-Profit Advancement (DANA). The recommendation was based upon the detail and comprehensiveness of DANA's proposal, cost, proximity, and Seaside's past experience with Sheila Bravo, DANA President and Chief Executive Officer, who had facilitated a retreat with Seaside's Board of Directors and key leaders in 2017. She had also worked with the Chesed Committee. The Strategic Planning Committee believes that DANA will contribute desirable objectivity and add professionalism to our strategic planning initiative.

At their December 17 meeting, the Board of Directors unanimously approved negotiating a contract with DANA. We anticipate that with the contract in place, work will begin in January with a goal of making a report to the Board next fall and a presentation at the 2024 Annual Meeting.

During the past few months, the Committee has also completed a preliminary analysis of Seaside's strengths, weaknesses, opportunities, and threats, which is commonly referred to as a "SWOT" analysis. The co-chairs have met separately with Rabbi Julie Danan and Rabbi Emerita Beth Cohen to gain their perspectives. The Committee will continue to work on identifying key stakeholders for future interviews and focus groups. In addition, we are planning a town meeting so that all Seaside members will have an opportunity to provide input.

December 2023 Board decisions

The Board approved the 2024 balanced Budget, as submitted to the membership prior to Seaside's November 19, 2023, Annual Meeting and reviewed and discussed at the Meeting.

The Board approved holding Seaside's third annual fundraising concert at Epworth Methodist Church with John McCutcheon on July 21, 2024.

The Board approved retaining DANA to provide expert consulting services for Seaside's ongoing Strategic

Planning initiative in 2024.

Seaside's Board approved making financial contributions totaling \$11,160.00 to nearly 30 local nonprofit organizations. Seaside actively supports the local community through participation with houses of worship and other nonprofits. Making donations is another way Seaside supports the volunteer efforts of local people in Delaware.

The Board approved naming Enid Zafran and Susan Heller as co-chairs of the Adult Education Committee.

At-large members Marilyn Feldman and Neil Trugman were there, and the Board noted a special thanks to outgoing members Joel Simon and Sara Rosen. Both remain active at Seaside in several different capacities.

"Volunteering for Seaside over the years has been a wonderful experience and I have learned a great deal," Peter Zoll says. "Now, from the perspective of a board member, I can assemble some of those teachings and integrate them with areas in which I was less involved. The Board has always had remarkable talent, and I am looking forward to being there as we begin a new phase of our service to the community."

Peter has been an active member since 2013 after he retired from the Washington D.C. area from a financial career. He has served for several years as chair of Seaside's Adult Education committee and has been active on the Building and the House committees, among others.

Shelley joined in the early days of 2002 as she was seeking a Jewish home after moving from Philadelphia. She served in management for Delaware Technical College in Georgetown before retiring and continues as a professional writer.

"As a new Board member, I am excited to learn how the Board accomplishes the work of the congregation, and I have a couple areas of interest that I want to focus on this first year," Shelley says.

Shelley cites helping to create transparency through better communication in what leadership does as one of her areas of focus.

"Open communications is essential to feeling connected to everyone," she says.

Shelley also wants to help ensure that everyone feels seen, heard, appreciated, and respected. This includes assuring the LGBTQ+ congregation members feel that Seaside is a welcoming and safe space. As a member of the Social Justice committee, Shelley will also contribute to Seaside's support of multifaith and other community efforts to fight racism, antisemitism, and all forms of hate.

The latest congregation members to volunteer for committee leadership include: Jodye Russell as Social Justice co-chair, and Fran Leibowitz as Worship Committee co-chair. Enid Zafran and Susan Heller have become co-chairs of the Adult Education committee. A complete list of committee chairs can be found in this newsletter.

January 2024 Board decision

The Board ratified the appointments of Jodye Russell as Social Justice co-chair and of Fran Leibowitz as Worship Committee co-chair.

Social Justice is an expansive committee that is made up of several subcommittees, including those that organize programming and action efforts to protect the environment, to combat gun violence, to fight for equal rights for the LGBTQ+ community, and to bring together people of different faiths.

SOAH spreads the word that "Hate Has No Place Here!"

Speak Out Against Hate **(SOAH)** was initiated in early 2023 after the occurrence of antisemitic and racist hate acts in the community to which there was no official response or action. It was the result of, at first, discussions between members of the Southern Delaware Alliance for Racial Justice (SDARJ) and members of Seaside Jewish Community's Social Justice Committee. It was noted that hatred was on the rise and that very few, if any, public officials were speaking out. The issue was "What to do?"

The strongly held opinion of the nine organizers (now comprising the first board of directors of SOAH as it incorporates and becomes a 501 (c) (3) organization), was that an effort was required to blunt and make unacceptable the hate that has become normalized and is transforming our culture. It was agreed that we must speak out against hate constantly and before hateful acts or incidents occur.

The mission of SOAH is simple:

Speak Out Against Hate **(SOAH)** has been formed for the express purpose of confronting and countering the rising tide of hate, wherever and whenever it exists in a direct, focused and ongoing manner. **SOAH** seeks to engage in this effort with all people of good faith; community leaders, businesses, elected officials, clergy, law enforcement personnel, young and old, regardless of color, creed, sexual orientation, national origin or religion. **SOAH** will speak out early, often and follow-up on the rising incidents and expressions of hate and join forces in this effort with all similarly motivated individuals and organizations. **SOAH** will insist that those in positions to execute policies and regulations speak out and develop strategies for legislation and policies to prevent this hateful and potentially destructive behavior. **SOAH's** goal is to make "No hate here" a reality in Delaware. All who are against hate are welcome to join **SOAH**.

In October, after organizing, planning and speaking about SOAH's mission throughout Sussex County and the state of Delaware, SOAH held its first public meeting. The response was incredibly gratifying; more than 170 people registered to attend either in person or via Zoom. At that meeting, SOAH announced that it was forming five Action Groups to meet with public facing officials: Faith Leaders, Youth and School officials, Elected Officials, Business Leaders, and Police Officials. Attendees were invited to join one or more of these Action Groups. The response to

that call to action was also excellent and soon thereafter the Action Groups began to meet and design going forward plans.

Since that time, members of the five Action Groups have begun to meet with their "target" audiences and are continuing to garner wonderful support for this nascent effort.

What has become apparent since its inception is that SOAH has created a platform upon which citizens frustrated and alarmed by the hatefulness that has arisen, particularly antisemitism, can come together to act against this change in the normalcy of our culture.

SOAH is now in its action mode. Speaking out about hate is our goal. Wouldn't it be wonderful if when you enter the State of Delaware, there is a sign that reads, "Welcome to Delaware. Hate has no place here!" You may contact SOAH at infoforsoah@gmail.com. Please join with us in this critical effort!

Notable Jewish Lives Estee Lauder

Thursday, February 15, 4-5 p.m.

Enid Zafran will talk about the life of Estee Lauder, a Jewish woman who started a cosmetics business from a beauty cream developed by her uncle. In 1998, she was the sole woman on *Time* magazine's list of the 20 most influential business geniuses of the 20th century. When she died in 2004, her family business was valued at \$5.1 billion. Today the family is also associated with its art museum philanthropy and even more notably for the Pink Ribbon Campaign they launched to end breast cancer.

The Prophet of the Andes: An Unlikely Journey to the Promised Land by Graciela Mochkofsky

Sue Rasher will lead the discussion of

this 2022 unusual true story of how one Peruvian carpenter led hundreds of Christians to Judaism, sparking a pilgrimage from the Andes to Israel and inspiring a wave of emerging Latin American Jewish communities. Seeking absolute truth in his religious practice, Segundo Villanueva questions and questions, until he becomes an Orthodox Jew in his impoverished village. He learns Hebrew, he gains followers, he meets resistance from the synagogue in Peru, yet he and his Jewish community persist.

When the Angels Left the Old Country by Sacha Lamb

Showcasing Ashkenazi lore, custom, and faith, this beautifully written story deftly tackles questions of identity, good and evil, obligation, and the many forms love can take. An angel and a devil have been studying together for centuries in a tiny shtetl, but pogroms and the search for a new life have drawn all the young people from their village to America. When one of those young emigrants goes missing, they set off to find her, taking the boat to New York City and dealing with the immigrant experience.

The first-time author, Sacha Lamb, received for this title: Sydney Taylor and Stonewall award; a Printz Honor book award; a National Jewish Book Award finalist; and the Mythopoeic Fantasy

The author makes up a Jewish family and here is a quote from her, "I'd heard about families with children conceived by in vitro fertilization who have additional children years later from leftover embryos. "I found this really fascinating," Enid says. "I was especially interested in the impact on the later child of learning that their family has essentially begun without them."

The Latecomer touches on the topics of grief and guilt, generational trauma, privilege and race, traditions and religion, and family dynamics. The book was a New York Times Notable Book of 2022; A Washington Post Notable Work of Fiction; An NPR Best Book of the Year; and A New Yorker Best Book of 2022.

Tu Bishvat

I remember how impressed my kids' friends were that Judaism celebrates a New Year of Trees, a time to plant and celebrate them. *Tu Bishvat* is a Jewish holiday that connects us with the Holy Land and the preservation of nature. In January we offered two opportunities to celebrate: a Tu Bishvat Seder and potluck lunch on January 21, plus a Green Team Climate Actions workshop on January 25.

Tu Bishvat means the 15th Day-at the full moon-of the Hebrew month of Shevat. (*Tu* being a shorthand for the letters *tet* and *vav*, whose numerical value is 15). Although it is still winter in northern climates, early signs of spring are appearing in Israel and other warm and Mediterranean regions.

Tu Bishvat has seen four meanings. It started as a mere "tax day" for tithing fruit for the needy in ancient Israel. In the diaspora, it became a traditional day to eat fruits that recall the Land of Israel, a custom developed most fully in the mystic's Tu Bishvat Seder. With the rebirth of Israel, it became a day for planting trees to reforest the country (the only one in the world to finish the 20th century with more trees than it began). Today Tu Bishvat has also become a time to focus on ecology and environmental stewardship.

Besides planting (or donating to plant) trees, we enjoy fresh or dried fruits and grains that remind us of Israel, such as the biblical "Seven Species" (wheat, barley, grapes, figs, pomegranates, olives, and dates), and others like almonds or carob.

The most elaborate type of fruit feast is the Tu Bishvat Seder. This formerly obscure Kabbalistic custom has made a comeback in recent years. Participants drink four cups of

wine or juice, starting with white for winter, and gradually adding more red for spring and summer. The ceremony includes four kinds of fruits representing the Four Worlds of Kabbalah: Physical (fruits with shells), Emotional (fruits with pits), Intellectual (wholly edible fruits), and Spiritual (scents alone), connecting us to the divine energy of the Tree of Life. The Seder often includes readings, songs, poems, and stories to celebrate trees and nature.
