President Saul Straussman called the meeting to order at 7:00 p.m. Rabbi Crystal led the board in Sh'ma/V'hafta and Kaddish.

A motion to approve the minutes was made, seconded, and unanimously approved.

# President's Report: (Saul Straussman)

Our Endowment Fund investments have been handled by Pittsburgh Wealth Management. Stu Miller, who has been Temple Sinai's broker, has left the firm for Miller McCurry/National Financial Services LLC. Motion was made, seconded, and unanimously approved to move our account so that it will continue to be administered by Stu Miller. A motion was made and seconded to adopt a resolution that Drew Barkley, Jerry Katz and Saul Straussman are authorized to conduct business on behalf of Temple Sinai. After questions and discussion, the motion passed unanimously.

### Treasurer's Report/Financial Update: (Jerry Katz & Mara Kaplan)

Mara provided an update to the year-end report, formerly presented in July. We ended the year with \$23,000 more in pledge collections than projected (or we collected better) resulting in a small surplus of \$20,000. Also, our expenses were lower than projected, particularly in security costs and the Torah project exceeded goal by a small amount. The small year-end surplus would remain in the general fund.

### **Transition Update: (Saul Straussman)**

Saul reported that the senior rabbi search committee has met several times and responded positively to the congregational survey report. The executive summary will be posted on the web site. As it stands, there is a ban on travel for rabbinical candidates. We will remain flexible with our plans during the pandemic.
