### Care of Our Building

In order to care for our beautiful building, including the sanctuary and school wing, we ask that members contribute \$2000 to our Building Fund. Members can elect to start paying immediately or can defer the first payment until the second year of membership. We offer members the choice of allocating payments over five or eight years.

Members are also asked to pay a \$275 Debt Service Fee every year to offset our Mortgage.

### Payment Guidelines

#### **Membership Commitment and Religious School Tuition**

Payments may be made to Temple Beth David by check, credit card (Visa or Mastercard) or electronic transfer (ACH/Echeck.) Our on-line member portal allows each congregant to set up a recurring payment plan for their convenience or to make payments individually. All payments must be complete by June 30<sup>th</sup> each fiscal year. We recommend the following options:

Single payment in July/August
Two payments – July/August and December
Half Year payments – July/August to December
Full Year payments – July/August to June

We strongly encourage congregants to set up recurring payment plans which will allow us to better manage our finances and facilitate the administration of billing and collections.

*Shorashim* Religious School Tuition becomes due upon registration and should be paid as follows: 50% before the first day that school begins in the fall, and 100% on or before December 31st. Exceptions are allowed if you set up a recurring payment plan.

50% of the Bar/Bat Mitzvah fee must be paid one (1) month before tutoring begins with 100% of the fee paid two (2) months before the Bar/Bat Mitzvah date. The fee will appear on your statement in July before the start your child's sixth grade year in order to provide additional time to spread out payments.

#### **Financial Assistance**

#### It is important to us that membership in our community is accessible to all.

Financial assistance may be requested by completing a *Confidential Application for Dues and Tuition Reduction* form. \* This form must be submitted to the attention of the Temple President as soon as possible. Reductions of Temple dues, Building Debt Service fee and/or Shorashim Religious School tuition will be approved on an individual basis. Building Fund and Bar/Bat Mitzvah fees cannot be adjusted; however, the Building Fund can be deferred to a subsequent year.
