#### YOUTH DVAR TORAH

One day, Yaakov was making a stew when his brother Esav came in from a long day of being in the field and asked for some of the food Yaakov was making. Yaakov immediately responds that he will give him the soup if he trades for his birthright, to which Esav agrees instantaneously.

Why would someone sell his birthright, which was worth an incalculable amount both spiritually and monetarily, for a bowl of stew? Esav gladly did so and then justified it because he was one day going to pass away.

Sadly, this is a similar explanation we use ourselves when we want to do something deep down we know is wrong. The problem with all of this is there is a tomorrow and it's precisely how you live today that will determine this tomorrow. Pointing out someone you know who never got sick and lived to 129 years old on a diet of whiskey, steak, and cigars doesn't give you the freedom to live recklessly and without limits. In fact, it's actually these stories that give you true free will to choose a correct and healthy path.

Esav cared only about what he wanted now. There was no thinking about tomorrow. This kind of thinking can lead someone to do anything he feels like doing and then proudly and confidently justify his behavior.

You can only truly feel great when you sacrifice short-term pleasure by investing in your future and doing what's right. God set up a system that demands that we grow. And this can only happen through fighting temptations and doing what's right. Then the lasting joy you'll own forever will be a much higher level than the temporary pleasure you passed up. And the more you're able to do this, the happier you'll be. Today and tomorrow.

#### **DVAR TORAH**

Parsaht Toldot

November 5-6

Recent excavations at the ancient biblical site of Gerar have unearthed portions of a transcript pertaining to a civil court case from over 3,800 years ago. The following are fragments from this remarkable find.

#### The Basic Charges:

The Plaintiff, Esau Isaacson, hereby alleges that the Defendant, Jacob Isaacson, who is his younger twin brother, wrongfully defrauded him of both his birthright and his paternal blessing.

#### **Deposition of the Plaintiff:**

Defense Counsel: Did you not willingly reject your birthright, saying what good would it do since you were about to die of hunger?

Esau: I was half-mad with hunger and not thinking clearly. Jacob knew this and deliberately made me swear to give it up. I'm just a simple hunter. He's the intellectual genius. Clearly I was coerced and shouldn't be held accountable. It was just a mess of pottage, after all.

#### Cross-examination of the Defense:

**Plaintiff Counsel:** Jacob, isn't it true that in response to two separate inquiries from your father, you averred that you were in fact Esau and tricked him into giving you the blessing that rightfully was meant for your elder brother?

Jacob: I was against that idea from the start.

Counsel: Well, which is it, Mr. Isaacson, were you lying then, or are you

**Jacob:** Look, this was all my mother's idea. I tried to talk her out of it. In the end I only acted at her behest. I am by nature a sensitive, cautious man. It's my brother who's the reckless one.

Counsel: So you claim. Yet, isn't it interesting that your very name Jacob -"He grasps the heel" – has the connotation of someone who is deliberately deceptive.

#### Direct Defense Testimony from the Boys' Mother:

Defense Counsel: Did you have a difficult pregnancy with the twins? Rivka: It became almost unendurable. I had been barren for so long and initially was so grateful to be with child, but the two of them were constantly struggling inside me.

Counsel: Will you please tell the court in your own words what happened when you sought Divine guidance?

Rivka: I received the word of HaShem, who told me that my babies would grow up to become two nations, and that the elder would serve the vounger.

Counsel: And isn't that why you commanded your son Jacob to impersonate his brother?

Rivka: Yes, you see, my husband was about to bless Esau, which was clearly against the will of HaShem. I did the only thing I could think of to stop that from happening.

#### **Summation of the Plaintiff Counsel:**

There is a rule of law that says "Res ipsa loquitur" - "the thing speaks for itself." In other words, the case for fraud is abundantly clear.

The Defendant admits it, and the facts prove it. Your Honor, you must in all fairness find for the Plaintiff and restore his birthright and his blessing.

#### Judgment of the Court:

While the Res ipsa loquitur argument is compelling, there is another tenet of law that states "In haec verba" – "In these words." In the case before us, we adjudicate that "these words" are not merely part of an historical record but bear a semblance of the Divine; ergo they have a higher standing. It is the opinion of this Court that neither Rivka's nor Jacob's actions constituted any malice. The mother merely wished to serve HaShem's larger purpose, which had been explicitly stated. The son obeyed his mother's instructions, which he is duty-bound to do. Accordingly, the Court rules in favor of the Defense.

#### Motion to Appeal:

There are times when people do things that technically are legal but still may be considered to be wrong. We submit that it is morally inexcusable for a wife to inveigle her son to perpetrate a hoax on his infirm, unsuspecting father. The Plaintiff, Esau, has been victimized, albeit under the guise of good intentions. Inexorably, his future is now hopeless and faithless. No one can know HaShem's mind, but surely His will could have been fulfilled in a less conniving, less harmful way. We respectfully appeal the ruling.




