2024 Camp Parent Agreement

- Registration is completed online through a CAI account on agudath.org.
- A \$100 non-refundable Registration Fee will guarantee your spot in the CAI ECC Camp Program. This non-refundable Registration Fee increases to \$200 after March 1, 2024.
- Once you receive an email confirming your child's registration, please log in to your CAI account to set up your payment method.
- Full tuition balance is due by June 1, 2024. You may pay tuition in one payment or in monthly installments. If full tuition is not received by June 1, CAI ECC at its option may prohibit child(ren) from attending the program until a payment has been made.
- Camp expenses are incurred whether or not a camper attends; therefore, refunds of any kind will not be made for absences or withdrawals from the camp program after June 1, 2024.
- Camp Program Dates are Monday, June 24 to Friday, August 16, 2024. Camp will be closed on Thursday, July 4 and Friday, July 5.
- Discounted Tuition applies for CAI congregants. For information about CAI membership, please contact Debbie Lurie at dlurie@agudath.org or 973-226-3600 x118.
- Siblings receive a 10% discount off the lower tuition. This excludes the Baby & Me program.
- A \$50 Change Fee applies to all changes to registration requested after May 1, 2024. This applies to a reduction in the number of days and/or weeks.
- A minimum registration is required to conduct each class.
- All applications are subject to the approval of the Camp or ECC Director. Tuition payments may only be applied to the current year and are not transferable.
- Updated child immunization records and a Universal Health Form are required to attend CAI ECC. Both must be updated at least annually.
