

## **OKC President's Letter June 2023**



How does a new President of Ohr Kodesh Congregation start her first letter to the Congregation? With gratitude.

- Designated Partners. In a separate piece, you will read more about our new Designated Partner
  initiative to facilitate ongoing communication with senior staff, the Board, and our greater
  community. One of our challenges has been eliciting productive feedback from our congregants
  and senior staff feedback that is shared and that leads to positive changes and growth and
  dialogue. This is a new process, and we look forward to gauging its effectiveness in the months
  ahead.
- 2. **Staff Development and Stability**. We are so happy to have been working with many dedicated professionals who have brought us to this point in time. But as Ohr Kodesh has been growing and our needs have and continue to change, we have been adjusting our staff configuration, pro- gramming, and resource allocation alongside. We thank Jerry Kiewe, our Executive Director for the past 16 year, for his dedicated service. We have plans to onboard our new Executive Director, Monica Saff, and to have her settle in with the current ebb and flow of our routines. Rabbi Helfand is coming up to his two-year anniversary and Rabbi Glazer, our Director of Lifelong Learning, is getting her first year under her belt. Cantor Labovitz, coming up on nine

years (!) with us, has also transitioned roles over time. We have a new Financial Management firm working with us to coordinate our new systems and we are looking to hire even more support staff in the near future. Our priorities are to ensure that our staff get what they need to do their jobs well in support of all the services and programs that our community needs, expects, and enjoys. And it is the Board's role to ensure that the work is getting done in a way that is responsive, efficient, and effective.

3. **Financial Stewardship**. Ohr Kodesh is lucky... no... blessed? No, that's not the word I'm looking for. Humbled/Amazed/Grateful that our community is financially stable, especially after two years of COVID-era challenges. We have a growing dues-paying membership that supports us and the programs we provide. And many members of this same community give over-and-above-dues to enable us to be in the strong financial position we are in. As a Board, it is our responsibility to make sure that the money coming into Ohr Kodesh is used in the most effective and responsible way possible. We need to address the current growth and changes over the past two years and what we think our needs will be in the future. To that end, we are launching a Finance Committee that – combined with our Budget Committee and Investment Committee – will position Ohr Kodesh to be strong and solid for many years to come.

That's a lot for a first letter. I'll end the same way I began – with gratitude for this community. I ask for patience and collaboration as we move through the next two years together.
