CONSOLIDATION AGREEMENT

THIS AGREEMENT, made this 6 day of November, 1988, in the Borough of Brooklyn, County of Kings, City and State of New York, by and between

CONGREGATION BETH-EL OF BOROUGH PARK, INC., a religious corporation of the Jewish faith, incorporated, organized and existing under the laws of the State of New York and having its principal office and place of activities at 4802-15th Avenue, Brooklyn, New York, hereinafter referred to or called "BETH-EL", and

YOUNG ISRAEL SYNAGOGUE OF BORO PARK, INC., a religious corporation of the Jewish faith, incorporated, organized and existing under the laws of the State of New York and having its principal office and place of activities at 1349-50th Street, Brooklyn, New York, hereinafter referred to or called "YOUNG ISRAEL".

WITNESSETII:

WHEREAS, by appropriate resolution duly adopted by both of the parties in compliance with applicable law(s), the parties have agreed to a consolidation, and

WHEREAS, it is the purpose and intention of the parties that their respective rights, duties, obligations and responsibilities in connection with such consolidation so duly

adopted be set forth,

NOW, THEREFORE, the parties have mutually covenanted and agreed, and by these presents do mutually covenant and agree to consolidate into a single corporation, pursuant to Section 208 of the Religious Corporations Law, upon the following terms and conditions:

- 1. The name of the proposed corporation is to be "YOUNG ISRAEL BETH-EL OF BOROUGH PARK".
- 2. The number of its trustees is to be no more than forty eight (48).
- 3. The time of the annual election and meeting shall be the second Tuesday in the month of March, in each year. Should said date be a legal or Jewish Religious Holiday, it shall be held on the Tuesday following which is not a holiday.
- 4. The names of the persons who are to be the trustees until the first annual meeting are set forth in the schedule annexed hereto.
- 5. All property, both real and personal, of both corporations shall belong to the consolidated corporation.
- 6. All worship services and other appropriate _ activities of the consolidated corporation shall be carried on in the present property of Beth-El.

7. SYNAGOGUE

A. Organization: The consolidated organization known as "Young Israel Beth-El of Borough Park" shall

constitute itself as a branch of the National Council of Young Israel.

B. Rabbi: Rabbi Dr. Israel Schorr, the esteemed Rabbi of Congregation Beth-El has a life contract with Beth-El and shall be the Rabbi of the merged congregation. The consolidated organization shall assume the life contract of the Rabbi.

All questions pertaining to observance and the religious law shall be decided by the Rabbi of the organization and his decisions shall be adhered to.

C. Chazan: In view of the differing traditions in the respective synagogues, namely, a Chazan in Beth-El and a Ba'al Tefilah in Young Israel, and in accordance with the expressed wishes and agreement of the Merger Committee, with full consultation with and the concurrence of the Young. Israel delegates, the Chazan shall remain under contract until August 31, 1990.

No later than January 1, 1990, the matter of continuing the services of the Chazan will be opened to consideration and discussion by the Board of Trustees and - the full membership, and a determination made by such membership in regard to any changes in this matter.

D. Officers: The elected officers of the organization shall be as follows: President; Chairman of the Board; 1st Vice President; 2nd Vice President; Treasurer; Financial Secretary-Comptroller; Recording Secretary.

(1) During the transition period constituting the first three years from the date of the signing of the merger agreement, in order to afford fair and full representation to both former organizations, the following pairs of officers shall not be represented by members of the same former congregation:

President - Chairman of the Board

1st Vice President - 2nd Vice President

Treasurer - Financial Secretary/Comptroller

- (2) The term of office of each officer elected in the initial election of the merged organization shall begin at the first meeting to be held for the election of officers which will follow immediately upon the signing of the merger agreement, or as soon thereafter as practicable. Such term of office shall continue until the next annual election or until a duly elected successor has qualified.
- (3) Thereafter, the term of office of each officer shall be one year.
- (4) Following the conclusion of the three year transition period, all officers shall be elected by the full membership at large, without regard to the former affiliation of such officer.
- E. Executive Board: The Executive Board shall consist of the seven elected officers, viz., President, Chairman of

the Board, 1st Vice President, 2nd Vice President, Treasurer, Financial Secretary/Comptroller and Recording Secretary and not less than twenty one (21) nor more than forty eight (48) elected trustees.

- (1) During the first two years of the three year transition period, a joint board shall be elected representing Beth-El and Young Israel members in equal numbers.
- (2) At the first election of the board, one third of such board shall be elected for a one year term, one third shall be elected for a two year term and one third shall be elected for a three year term. Each third shall represent.

 Beth-El and Young Israel memberships in equal numbers.
- (3) At the appointed expiration of the elected term of each board member, the replacement members shall be elected for the succeeding full term of three years by a vote of the full membership. Only the replacement members of the first third of the board shall be required to represent the former organizations in equal numbers.
- (4) An Advisory Board of unspecified number shall be constituted as an adjunct to the Executive Board. This Advisory Board shall be without voting power.
- F. Membership Voting: On matters requiring the full vote of the general membership, the membership vote will be determined by unit voting for the first three years of the transition period.

8. BUILDING. It is agreed that while the landmark synagogue of Beth-E1 has had continuing maintenance and repair work to maintain its excellent state, certain capital improvements are or will be required in the immediate future, either as a direct result of the merger needs or due to improvements required and arising in the ordinary course of events.

A. Mechitza: A Mechitza shall be constructed in the synagogue on the 48th Street side of the ground floor interior. Such mechitza shall be constructed in strict accord with and under the supervision and guidance of Rabbi Schorr, to ensure that it conforms with halachic requirements.

- (1) A separate entrance providing direct access from the street shall be constructed on the 48th Street side of the synagogue.
- (2) The mechitza section downstairs will encompass seating space for approximately 250 seats.
- (3) Design and construction shall be undertaken immediately upon the signing of the merger agreement and shall proceed as expeditiously as possible.
- (4) Additionally, the seating for women upstairs shall continue undisturbed.
- B. Window Repair: While this undertaking has been the subject of discussion as part of the contemplated repair work to be undertaken after merger, Congregation Beth-El has moved ahead on this repair work and it is already underway.



C. Other Anticipated Capital Improvements: At the present time, the following capital improvements are or in the foreseeable future will be in need of attention and shall be undertaken:

New boiler

Aisle carpeting

New sidewalk

Conversion of air-condioning to air-cooled units in the Social Hall

No other major repairs or capital improvemnts are contemplated and no major defects are known to exist at present.

D. Plaques, Memorial Tablets and Other Items:
Plaques and Mcmorial Tablets presently located in the Young
Israel Synagogue shall be relocated to the Beth-El Synagogue
and placed in appropriate and suitably visible locations.

The flagpole erected by the Jewish War Veterans and the accompanying plaque shall be suitably relocated at Beth-El.

E. Cost: The estimated cost of all the building improvements referred to in this section, including those already undertaken, totals approximately \$300,000.00. Both synagogues fully understand the need for and agree to these expenditures. After the assets of the two synagogues are combined, funds to cover these expenditures shall be made fully available.

9. RITUAL

A. Aliyas:

- (1) Any and all forms of commercialism in connection with the services shall be strictly prohibited, and this is to apply with particular reference to aliyas.
- (2) A policy of eight aligns shall be maintained on a regular Shabbos, as a general rule.
- (3) Chiyuvim desiring an aliya will be limited to those with a Yahrzeit, a Simcha such as an Aufruf, Bar Mitzvah. or the Naming of a Child, etc.
- (4) MiShebarach policy shall conform with the "no commercialism" standard.
- B. Kibudim: Kibudim on the Yomim Noraim shall be based on service to the Shul. Any person accepting a kibud on Yom Kippur must conform with the Halachah and shall not enter upon the Bimah while wearing leather shoes.

The policy in present practice at Beth-El of offering Pesicha of the Aron Kodesh to two persons at a time in order to accommodate a greater number of mispallelim is herewith endorsed and shall be adopted as the practice of the merged congregation.

C. Appeals: An Appeals Committee shall be constituted to discuss the nature and number of appeals to be conducted during the year. The Young Israel holds twelve (12) appeals annually, some of a compound nature, and Beth-El

conducts seven (7) appeals annually. The appeals are to be evaluated and combined in order to keep the number to an agreeable minimum.

There shall be no appeal on Kol Nidre night.

10. : WELFARE

- A. Welfare membership and privileges shall continue undisturbed for each present member in accord with the present rules governing each respective organization's welfare group.
- B. New applicants who wish to join the Congregation can and may apply for cemetery privileges and will be accepted subject to the following terms and conditions:
- (1) In the case of an applicant who is forty five (45) years of age or younger, there will be no initiation fee.
- (2) In the case of an applicant who is over the age of forty five (45), an initiation fee of ten (\$10) dollars for each year the applicant is over the age of forty five (45) shall be charged.
- (3) New members can request their choice of cemeteries, but the ultimate decision shall be made by the welfare committee.
- (4) There will be no charge of any dues for belonging to the Chevra Kadisha.
- (5) New member interment after merger shall alternate between cemeteries to the extent possible.

(6) Persons over the age of fifty (50) who do not want graves or cemetery privileges through the organization, shall sign a waiver to that effect.

11. ASSISTANT RABBI

In consideration of the requirements of the merged congregation, the need for an Assistant Rabbi may arise in the foreseeable future. After appropriate consultation with Rabbi Schorr and with due deference accorded his suggestions and wishes, consideration shall be given no later than six (6) months from the date of the signing of the merger agreement to the hiring of an Assistant Rabbi.

The decision in regard to this matter shall be made by a vote of the entire membership by secret ballot.

12. CONTRACTS

The merged organization will assume all present contracts, debts and liabilities of the separate organizations, as presently constituted, with the exception of the leasehold presently held by the Young Israel Synagogue of Boro Park.

Neither organization shall individually enter into or undertake any new contracts which will become binding upon the merged congregation. Only emergency or short term contracts which will expire or can be terminated before the final acts of merger take place shall be undertaken when absolutely necessary.

IN WITNESS WHEREOF, the said parties have <u>caused</u> this agreement to be executed by their duly authorized officers and their corporate seals duly attested to be affixed hereto the day and the year first above written.
