Failure by any member to pay dues or assessments during the fiscal year in which they become due will result in the member losing all rights and privileges of membership.

<sup>1</sup> Family Membership is defined as any married or cohabitating couple with or without dependents. If one member is not Jewish or is not inclined to participate or engage in Judaism, the couple is still considered a family unit.

<sup>2</sup> Associate refers to any family or individual who already belongs to another congregation. Proof of this membership is required for an associate membership in PJTC.

<sup>3</sup> Single Membership is defined as an unmarried individual with or without dependents.
