## **Message From the Rabbi**



For my dear Schomre Israel Family and Friends,

They say of a story that occurred during the Poughkeepsie Jewish Community's days of olde. One afternoon, the rabbi was emersed in his studies when the ball playing of the local youth kept distracting him. Looking out the window he called out to the lads, "Have you heard? There is a two-headed one-eyed purple goat on the other side of the bridge, eating potato kugel". The youth dropped what they were doing and started running towards the bridge. "Finally", the rabbi thought, "some quiet for my studying". A

few minutes later he hears a commotion outside his house. Looking outside his window, he sees many Schomre members running towards the bridge. "What is going on?" he called out to them. "Haven't you heard? There is a there is a two-headed one-eyed purple goat eating potato kugel on the other side of the bridge." The rabbi quickly donned his coat. "Who knows", he mused, "If everyone is saying it than it must be true".

Yes, a silly story, but one that summarizes some of the aspects of post-modern American Antisemitism.

There was a much-discussed news story that transpired with our neighbors in the north, at Bard College, where they recently introduced a class titled "Apartheid in Israel-Palestine".

Now before I continue, I would like to offer the following disclaimer: The views and opinions expressed in this article are those of the author and do not necessarily reflect the views or positions of Schomre Israel, its board, affiliates, subsidiaries, employees, or sponsors.

I personally believe that one has the right to express views that are contrary to my opinion and the truth. And people are protected to say whatever they want, as long as they do not incite violence or harm, regardless about how hateful or antisemitic it is. However, to remain silent when antisemitism runs rampant is a crime that history has taught us cannot be tolerated. On the other hand, to scream "antisemitism" every time we feel like it when no actual antisemitism is being displayed would be destructive as well. So, is Bard's class antisemitic in nature, which should elicit a protest from us, or not?

As I was writing this article, a very hate-filled and ugly event started unfolding in another college. On May 12 the City University of New York invited a student speaker to address their Law School's graduation. I will not disgrace my article by quoting what she said (you can easily watch or read it on the web), but she went into a very libelous hate-spewed deceitful tirade against the USA, NYPD, capitalism, Zionism and Israel. As a rule, regardless of the topic, graduation is a time for optimism and hope and should never be used as a platform for destruction, especially one full of hatred and lies. And this low-down used this opportunity, this platform that was given to her, to promote hatred and antisemitism. Yet the real tragedy of the event, is that not only did not a single faculty or student walk out to protest, but they also cheered every lie that she spewed. And even worse, the CUNY Law school Dean walked over after she concluded to applaud her and her speech.

One would assume that for this lady to talk so arrogantly against the United States and Israel, she must have been wronged by them. But alas, the exact opposite is true. She was born in disease-ridden Yemen, where the Houthis, Iranians, and Saudis were busy killing and tormenting the people there. Do you know which country had nothing to do with their hardships: Israel. And it was the United States that offered her and her family a safe refuge. Yet her unfounded hatred was so strong that those two countries became her enemies and the target of her hatred..

"Well obviously", I can hear you thinking, "The President and leadership of the College right away stood up and condemned it." Not at all. Even after the next day when she tweeted her pride in "praying for the death of the USA on a public platform" the College rushed to her defense, gushing about how accepting and proud they were to have her talk. It was only after Representative Lawler introduced legislation to strip federal funds from antisemitic colleges did CUNY, two weeks later, offer a lukewarm half-apology.

Well, you may ask, are the college's leadership really to blame because of the statements of one student? Unfortunately, the answer to this as well is yes. Purportedly, the Law College's leadership pre-approved her speech before she gave it. And even if they didn't, her multitude of hate and anti-Jewish remarks from previous years (such as her 2021 tweet that "every Zionist burn in the hottest pit of hell") should automatically brand anyone that would allow her to speak at their institution as an abettor for her hate. However, the biggest indication of their accessory for anti-Jewish and Israel hate speech is the glaring fact that this is not the first time that they allowed and encouraged a student's hate to be promoted during their Law school graduation. The previous year, the Law School allowed another hater to speak at their graduation, one who before-hand had explicitly stated that Israel be wiped off the map. And these actions are a product of their many anti-USA, anti-Israel and Anti-Jewish classes and teachings through the last few decades.

Which leads me to a similar story that occurred a few years ago, which from its analysis one can see an obvious path to combat this unfounded hatred.

In 2019, University of North Carolina hosted a three day "Conflict over Gaza", an initiative which was part of the US Department of Education's \$235,000 grant to the Duke-UNC Consortium for Middle East Studies. Unedited videos showed a professor explicitly stating that people have the right to punch and knockout unsuspecting Jews to retaliate against the oppression, amid a host of other very anti-Jewish sentiments. The video that attracted the most attention, was an auditorium packed with people singing very antisemitic lyrics with a rapper (who was not funny and not much of a rapper). They joined in as he stated, "I need your help. I cannot be antisemitic alone."

And where was the outrage? The initial statements from the University denied any antisemitism, claiming that they had the rights for open speech, and no one should have taken videos. It was only after Representative George Holding wrote to Secretary DeVos that the University issued a formal apology. And after much pressure the University eventually returned the grant back to the DOE.

While I cannot say for certain, I do not think that I have heard of any major University-sanctioned antisemitism in UNC. The reason: bad PR and the threat of losing state or federal funds.

And here lies our course of direction. Colleges and universities will cower their antisemitism under the guise of free speech. Regardless about the fact that if one whispers anything negative about other minorities, they will rush to condemn it. However, for some reason that pursuit of respect and social justice does not emerge when Jew-hatred raises its ugly head. The only time that they allow themselves to open their ears is when their funding is being threatened.

When an event such as the ones that occurred in CUNY or UNC takes place, the colleges' leadership must understand how this is completely unacceptable. Maybe, if the law firms would grow some guts and proclaim that they would consider the hatred level of the school that the applicant graduated from during the hiring process then the schools would open their eyes. While CUNY's law school is a bottom tier school to begin with (154 out of 200), I am sure that they would take a dip in their ratings seriously.<sup>1</sup>

What can we do? Glad you asked. As mentioned earlier, history has taught us that we cannot remain silent to such base hatred. For hatred flourishes in inconsequentiality and apathy. Many decades ago I had my property vandalized with antisemitic writings in CCBC because of an Israeli flag that I had on my car. When I went to report, the initial response of the security was one of disbelief and incredibility. When I finally convinced him to check it out, he was in shock about what had occurred. I do not know if he initially refused to believe me because of ignorance, reputation, laziness or antisemitism, but the message is the same: ignore antisemitism, don't report it.

Antisemitism is becoming worse and worse in colleges and universities. When I worked at Columbia University, a Jewish coworker told me that she no longer feels safe walking there at night. This is a University that invited Gaddafi and

Ahmadinejad to speak under the pretense of Free Speech while concurrently closing down the ROTC. And this is only a drop in the bucket.

While the US Constitution does give people the free right to be and openly express antisemitism and idiocy, as decided upon during the 1977 Skokie Affair, the people also have the right to protest those who are financing such antisemitism and idiocy. So who are the ones financing CUNY Law School and its longstanding antisemitic faculty, staff and speakers? YOU ARE. According to CUNY's official website: "The State of New York is the principal funding source of the University." To the tune of over 276 million dollars a year.<sup>2</sup>

The reason why CUNY has expanded its Jew-hatred to incorporate it into a long and much applauded graduation speech was because the year before, when a smaller-scale anti-Jewish graduation speech elicited almost no protests. And that speaker was allowed to speak because of the decades long policies of antisemitism practiced and promoted by CUNY's staff and faculties. Antisemitism follows the old French teaching, "L'audace, toujours l'audace – audacity, always pursue audacity". When antisemitism becomes accepted as normal, even those proposing to be against it will follow its lead. We will be having progressive Jew-hatred at such an alarming rate, that what was considered extreme hatred just a few years before will become normalized in a short amount of time.

We cannot remain silent. We must promote the idea that if you want to be antisemitic then you do have the right to be so; but not on our money. I have written to my representatives to protest the antisemitism at CUNY and to not allow their hatred to go unchallenged. And I encourage everyone to do the same. We should not be forced to pay for such hatred, and yes evil, in our midst. And we should encourage those who have been bold enough to take on this fight, to let them know that we are on their side.

We cannot remain silent.



#### THE SIGNIFICANCE OF TISHA B'AV

The saddest day of the year, Tisha B'Av, commemorates several tragedies. These include:

- A. The Hebrew spies returned from their reconnaissance of Israel, filling the Jewish people with negative reports. The Jews cried that night against Hashem which caused that generation to be denied access into Israel and started a night full of tears for generations.
- B. The destruction of both the first and second Temples in Jerusalem (420 B.C.E. and 70 C.E.).
- C. The fall of Bethar in the Bar-Kochba rebellion (135 C.E.).
- D. This disaster marked the end of all Jewish aspirations for freedom from Rome. To signify the destruction of the Jewish people, the Romans plowed over the Temple Mount.
- E. In later centuries other sad occurrences were associated with this day. Among them the expulsion of the Jews from Spain in 1492.

The severity of Tisha B'Av equals that of Yom Kippur in that both fast days commence on the previous evening. The atmosphere in Shul is gloomy, the lights are dimmed, the curtain is removed from the Ark and most worshipers sit on low stools or on the floor. The Book of Lamentations (Megillas Eichah) is read, and the special Kinos (prayers of lamentations) are recited.

Among other Halachic injunctions observed on Tisha B'Av are:

- 1. Complete fasting.
- 2. No bathing.
- 3. No conjugal relations.
- 4. No leather shoes are worn (rubber or canvas shoes are allowed).
- 5. It is even prohibited to study Torah on this day because Torah study is considered a very great joy and happiness. (There are certain texts that are permitted).
- 6. It is not customary to greet people with the usual greetings such as "hello" or "good morning". However, if you are greeted by someone who doesn't know the law, you should answer in a soft voice in order not to offend or hurt their feelings.
- 7. One should try to avoid business transactions or important decisions on this day if possible. Needless to say, in all cases where health is an issue the law is very lenient. The Rabbi should be consulted in all such cases.

Which takes us back to Bard College.

Is the course that they teach antisemitic? Should we protest against it?

I was cautioned against weighing in on this topic, as I have not gone to the class and do not know what is taught. And this is true, I do not know whether or not the course itself is antisemitic. However ...

As a general rule, (not necessarily applicable here) I feel that there are a few indications whether a speaker or action is or allows antisemitism. The terms of "from the river to the sea, Palestine will be free" or "erase Zionism from the map" is a call for the genocide or expulsion of 6.8 million Jews. Anyone accepting or allowing anyone who makes that comment to address an event or talk, is antisemitic. Anyone that will not allow for the production or the sale of their product in Israel while allowing it to be sold in countries which are *Judenfrie* or genocidal, are antisemitic. Anyone who promotes open lies and falsehoods, such as the fact that Israel is indiscriminately slaughtering thousands of innocents, is antisemitic. Any group or entity that does not allow a Jew to join based on their beliefs, is antisemitic. Anyone who gives out candy or celebrates when innocent Israelis or Jews are murdered, is antisemitic. Anyone who distorts history, such as statements that the Holocaust never happened, that the Jews never historically lived in Israel, that the Kotel was never part of the Temple, that the Arabs welcomed Israel during the War, etc, are antisemitic. Anyone who singles out Jews in a derogatory way either falsely or when other groups are worse, are antisemitic.

So, what about Bard's "Apartheid in Israel-Palestine" course. While yes, I have not been to the course, and yes, I do not know what is being taught, I am going to give my opinion anyways. When one creates a course title which is insidious, even if the material itself offers views all sides and teaches an objective explanation, the projection of the class and its real intent will be interpreted as intended. If there were to be a class titled, "The many problems of the United States caused by <<pre><<pre>place any minority here>>", even if the class itself goes on to explain how it is not minority's fault, it would rightfully so be considered racist. And if that minority would not be Jewish, would be condemned and blocked by everyone at Bard.

Is it possible that Israel is actually apartheid, and therefore the class itself, with its title is actually justified? The term apartheid comes from South Africa, where various minorities were not allowed to be hired or share facilities that other groups had access. Israel on the other hand, allows Israeli Muslims and Arabs to be voted into the Knesset, even allowing them to form a very powerful voting bloc, allows them to go to any of the Israeli classes and courses, to work anywhere, live anywhere, attain any political position, go as a patient, nurse, or doctor at any hospital, have any religious worship that does not encroach on other religions, and enjoy any entertainment equally as well. So yes, calling Israel Apartheid when many of her neighboring countries and provinces will not allow a Jew to walk in their streets alive, is antisemitic. So, to the Bard leadership who approved this class: Shame on you.

So, what should we do about this? As it is a class that does take on another viewpoint, one which I do fault the leader-ship as singling out a country of Jews and therefore find antisemitic, formal classes that have been approved do have the right to teach. What I think is so important is for the community, and yes, the politicians, to let Bard know that we are concerned, that we are watching. We must engage with them and explain why antisemitism and hatred are so painful and wrong. They must know that we will not allow the teaching of antisemitism to go unchecked, and if they start allowing more and more antisemitic rhetoric and policies, we will be there to let the governments know that there may be better places to allocate our tax dollars.

For if we truly remain silent, and I hope I am wrong, it will not be long before Jews feel uncomfortable, and Bard will start looking more and more like CUNY Law School.<sup>4</sup>

One Sunday I veered off to check it out and found myself at the "Hall of Fame for Great Americans". I went over to the CUNY library and asked the librarian about the history of that building. 
## A Walk down Schomre Israel's Memory Lane – all the way back to 2017

Any questions about the Eruv may be directed to haroldwrpr@aol.com or Rabbi Gavriel Bechhofer of Monsey, who served as our Eruv consultant and insured that the Eruv met Halachic requirements.

The implementation of the eruv was supported by a grant from the Frances Davis Foundation. In recognition of this support the eruv was dedicated as the Frances Davis Memorial Eruv.

## After 130 Years, Poughkeepsie's Jews Get an Eruv \* April 25, 2017



In the rich, nearly 130-year history of the organized Jewish community in Poughkeepsie, NY, pushing a stroller or carrying any possession in public areas on Shabbat — without violating the laws of the day of rest — was out of the question.

The observant Jewish community of New York State's Mid-Hudson Valley isn't the super-sized Jewish experience of New York City or its suburbs, but you could still find a weekly Torah class, immerse in a beautifully maintained mikvah or attend a Jewish War Veterans meeting — and, now, after a six-year effort, you can also find have an eruv.

The project was led by a dedicated force of nature named Harold Warren, a retired court stenographer and the second vice president of Poughkeepsie's historic Congregation Schomre Israel.

Warren decided Poughkeepsie needed an eruv — the halachically-required boundary allowing Jews to carry in public spaces on Shabbat — when he noticed that many young couples were leaving, in part because the city lacked.

As Poughkeepsie's younger Jews "became more educated than their grandparents, [they] expected more infrastructure" for the local community, Warren told *The Jewish Link*, and when they found none, they left.

When Warren and his wife became more observant some 10 years ago, he delved into the daunting tangle of red tape involved in eruv construction (in modern times, an eruv is typically wires mounted on telephone poles). This included dealing with utility companies, municipal rules and local officials — in addition to educating the mostly non-Jewish residents of the city about this foreign concept.

There was a lot of "jumping through hoops," Warren recalled, as he worked at this project for more than half a decade.

After obtaining a foundation grant for the eruv, he started the process of explaining the Jewish legal concept to the region's Central Hudson Gas & Electric Corp. as well as Verizon. Then came meetings with two different municipal government agencies: the City of Poughkeepsie and the Town of Poughkeepsie. The city consists of some 25,000 residents, while the town is comprised of unincorporated villages and is home to more than 140,000 people.

Each time elected offices changed hands, Warren would need to again explain the eruv concept to new officials who were unfamiliar.

Throughout the process, Warren worked closely with Rabbi Yosef Gavriel Bechhofer from Monsey, NY, an expert in eruv construction and planning.


Finally, with the utility companies on board and the municipal officials up to speed on their Jewish knowledge, the eruv received the proclamations and resolutions it needed earlier this month.

Warren said he is excited "to get the word out" about Poughkeepsie Jewry's major win. "This is the beginning of reviving an old and friendly Orthodox community," Warren said, adding he's excited to put Poughkeepsie "on the Jewish map."

## Poughkeepsie eruv 1st in Mid-Hudson Valley \* April 26, 2017

It isn't the super-sized Jewish experience of New York City or the Five Towns. But while the Mid-Hudson Valley still has plenty to offer observant Jews (including Orthodox shuls and a mikvah), pushing a stroller or carrying any possession in public areas of Poughkeepsie on Shabbat was out of the question — before Harold Warren began his six-year effort to erect the area's first eruv.

Warren, a retired court stenographer and the second vice president of Poughkeepsie's historic Congregation Schomre Israel, a Modern Orthodox shul, saw many young couples leave the area for several reasons, including the lack of an eruv.

An eruv's boundaries are typically marked by wires mounted on telephone poles. Warren dared to delve into the daunting tangle of red tape involved in eruv construction, such as unknowing utility companies and unfamiliar municipal officials. It's difficult enough to put an eruv together in a larger city, but for non-Jewish residents of a

smaller town like Poughkeepsie, the word "eruv" is absolutely foreign.

As Poughkeepsie's younger Jews "became more educated than their grandparents," they "expected more infrastructure" for the local Jewish community, Warren told Jewish Link. The area once had a Solomon Schechter

Day School (affiliated with Conservative Judaism), but it closed. With no kosher restaurants in the immediate vicinity and no eruv, young Jews started leaving.

"It became more difficult to keep people here," Warren said. "My wife and I became more observant, and we joined Schomre Israel 10 years ago. I said that we needed an eruv. We needed an eruv first, so we could start a day school."

After obtaining a foundation grant for the eruy, Warren started the process of explaining the Jewish legal concept to the region's Central Hudson Gas & Electric Corp. as well as Verizon. Then came meetings with two different municipal government agencies—the City of Poughkeepsie and the Town of Poughkeepsie. The city consists of some 25,000 residents, while the town is comprised of unincorporated villages and is home to more than 140,000 people.

Warren worked closely with Rabbi Yosef Gavriel Bechhofer from Monsey, an expert in eruv construction and planning. There was a great deal of "jumping through hoops," Warren recalled. Over the course of six years, when elected offices changed hands, Warren would need to repeatedly explain the eruv to new officials who were unfamiliar with the concept.


Finally, with the utility companies on board and the municipal officials up to speed on their Jewish knowledge, the eruv received the proclamations and resolutions it needed earlier this month. The new task, according to Warren, is "to get the word out" about Poughkeepsie Jewry's crucial rite of passage.

"This is the beginning of reviving an old and friendly Orthodox community," he said.

The synagogue vice president moved his family to Poughkeepsie because he always found New York City "too crowded and fast-paced," and was offered a job in Poughkeepsie.

"It's a nice small town with a couple of local theaters and golf courses. The Mohawk Preserve is a lovely place for hikes," said Warren, who expressed the desire to ensure Poughkeepsie is "on the Jewish map."
