THE START OF THE 125TH ANNIVERSARY YEAR

Dr. Nathalie Friedman, Chairperson of the 125th Anniversary Celebration introduced the kickoff event at the Annual Meeting and Hachnasat Sefer Torah, the dedication of our new Torah. It took place on Sunday morning, April 6, in the Main Synagogue and on 85th Street. She expressed particular appreciation to Linda and Michael Jesselson for their thoughtfulness and generosity in commissioning the writing and

presenting of this Torah to Kehilath Jeshurun on this occasion. She quoted from the daily Maariv service when she said: "Ki hem chayeinu v'orech yameinu u'vahem ne-hegeh yomam va'layla — the Torah is our life and the length of our days and on its commandments we will meditate." She spoke of the appropriateness of KJ recognizing and celebrating its 125th anniversary by dedicating a new Torah.

THE DEDICATION

Rabbi Lookstein then thanked the large assemblage of people who came to participate in the dedication. He invited everyone to leave the Main Synagogue and go out onto 85th Street where all the Torahs of the congregation would be, in order to escort the new Torah under a chupah. Amidst very leibidik singing and dancing to the tunes of a Klezmer group, hundreds of members thrilled

to the excitement of this special day. It was an exciting and spirited welcome that will long be remembered by all of the members of the congregation who were fortunate to be there. The assemblage then returned to the Main Synagogue to receive the Torah and witness its placement in the ark surrounded by all of the other Torahs of the congregation.

SHIVAH ASSAR B'TAMMUZ, TISHA B'AV AND THE THREE WEEKS JULY 22 - AUGUST 12, 1997

During the summer months, we mourn the destruction of both Temples in Jerusalem which took place on the ninth of Av. and the events that led to their destruction. We fast on the seventeenth day of the month of Tammuz, Shivah Assar B'Tammuz because, according to tradition it was on that day that the enemy penetrated the walls of Jerusalem prior to the destruction of the Second Temple. The Talmud, however, writes that these were not the only tragedies that befell the Jewish people on this day. On the seventeenth of Tammuz four more tragedies occurred: the first tablets containing the Ten Commandments were broken by Moses, the two daily sacrifices were suspended during the time of the First Temple, the wicked Apostumos burned the Torah, and an idol was erected in the Temple.

Additional tragedies also befell the Jewish people on **Tisha B'Av**. On this day, the *meraglim*, the spies, returned to the Jews in the desert with a negative report about the Land of Israel. In addition, it was on this day that the city of Betar was destroyed and tens of thousands of Jews were killed, and the day the wicked Turnus Rufus plowed the site of the Temple and its surroundings. Tradition asserts that the expulsion of the Jews from England in 1290 and the expulsion from Spain in 1492 also took place on **Tisha B'Av**.

Our mourning for the destroyed Temples and for the other calamities which occured on these days extends

beyond the fasts themselves. The period between these last two fasts, traditionally called The Three Weeks includes several practices mourning. During these three weeks we do not get our hair cut, attend weddings or involve ourselves in large joyous gatherings. During the nine days which begin on the first of Av, August 4, and continue until midday on the tenth day of Av, August 13, we are additionally forbidden to eat meat and drink wine, except on Shabbat, to go swimming or bathe for pleasure, and to do any laundry or dry cleaning that is not absolutely necessary. In general, the Talmud writes that when the month of Av begins, our mood should reflect our mourning for the destruction of the Temples. On Tisha B'Av itself, besides fasting, we are prohibited from washing our bodies, wearing leather shoes, anointing ourselves. and marital having relations. It is also forbidden to study Torah on this day with the exception of the sections of the prophets and the Talmud that discuss the destruction. We do not wear our tallit and tefillin until Mincha and the custom is to sit on low chairs like mourners until midday. Our observance of mourning also forbids us from greeting friends on Tisha B'Av.

We mourn the Temple that was destroyed over nineteen hundred years ago and we pray that in the merit of our mourning we will be worthy to see God rebuild the Temple in our lifetime.

Rosh Hashana begins this year on Wednesday evening, October 1, and continues on Thursday and Friday, October 2 and 3. Yom Kippur is on Friday evening (Kol Nidre) and Saturday, October 10 and 11.

Rabbi Lookstein expressed gratitude to Dr. Nathalie Friedman and her committee of more than forty members including vice-chair, Robert Kurzweil and co-chairs Benjamin Brown and Dr. Gilbert N. Kahn for their dedication, imagination and creativity in planning the thirteen months of events in celebration of the

125th anniversary. Similar gratitude was expressed to our Executive Director, Robert Leifert, who actually first conceived of the nature of our thirteen month 125th anniversary observance and celebration.

The morning's program concluded with a beautiful buffet brunch in the Auditorium.

KJ ARCHIVES EXPLORED YOUR DOCUMENTS WANTED!

As part of our celebration of the 125th anniversary of KJ we are undertaking several projects that we expect will prove useful to the Congregation. First, we are using our archives to select items, recalling the past, which will appear in the KJ Bulletins of this anniversary year. Second, we intend to refurbish the archives, replacing the current, old file boxes with new, sturdier ones that are easier to handle. We want also to create a pleasanter, more protected storage area for the archives.

Our main goal is to make the

archives accessible to scholars and students of American Jewish History. We are being advised by Steve Siegel, Archivist of the 92nd Street Y, and with his help, the work will be underway this summer. This first stage should be completed within the year. As part of the archives project, we have scheduled visits with the archivists of Shearith Israel, The Spanish and Portuguese Synagogue and Central Synagogue. We will also visit the newly established museum Emanuel Temple seeking information and ideas that can benefit our community.

MEMBERS SOUGHT FOR ORAL HISTORY

Our second major project is an oral history of members of the congregation who have been involved with the major commitments of KJ to maximum Jewish education (our work for Yeshiva University and the signal achievement of Ramaz) to Israel, to the successful rescue efforts of Soviet Jewry and to the enhanced role of women in Jewish life and worship. We

will work with experienced people who will provide the necessary guidance. We will start the work of planning and assume that such a major undertaking will extend well beyond this anniversary year. If we are successful, we will have valuable information that will enrich our understanding of these historic efforts and achievements.

ONGOING EXHIBIT

We also aim to create a changing lobby exhibit of documents and other items identified with our history. If you have items to submit or lend to this effort, please contact Robert Leifert at the Synagogue office (427-1000).

Our thanks to Professor Naomi Miller who is chairing this committee and to its members Rae Gurewitsch, Yvonne Koppel-Kopans, and Toby Joseph who took considerable time to work on our dusty ancient basement files.

MEN'S CLUB CONCLUDES ACTIVE SEASON

The KJ Men's Club just completed an exciting season of events with its annual Shavuot Dinner on the first night of Shavuot, preceding the Tikun Leyl Shavuot. Over 275 people attended the event. In addition to a sumptuous Yom Tov dinner, divrei Torah were presented by members of the Men's Club Board and by over twenty-five children of the 4tH, 5th and 6th grades of the Ramaz Lower School. This concluded a wonderful season of activities of the Men's Club. which included a series of Parent-Child Minyanim (co-sponsored with the KJ Youth Department), the Seudah Shlishit program, the Sunday Supper Lecture Program (with Judge Harold Rothwax), Men's Club Shabbaton (at which members of the Men's Club led the Shabbat services) and Men's Club Chol Hamoed Sukkah Supper (with Mayor Rudolph Guiliani).

The Men's Club is now planning its program for the next season, which will be announced in the fall.

SHAVUOTH BULLETIN

SHAVUOTH IN THE SYNAGOGUE

Shavuoth, the Feast of Weeks, commemorates the giving of the Ten Commandments on Mt. Sinai. It is also known as "Chag Habikurim" the Festival of First Fruits, a very joyous occasion in ancient as well as in modern Palestine.

Our synagogue, as usual, will be fittingly decorated with flowers and greens in honor of this holiday. We expect a large attendance on both days, Wednesday and Thursday, to share with us the joy and beauty of the festival.

On Tuesday night after dinner the custom of saying "Tikun" will be observed in the chapel. There will, of course, be the usual smokes and holiday refreshments. All men are cordially invited.

On Wednesday morning, the first

day of Shavuoth, the scriptural reading will include the Ten Commandments. This will be preceded by the chanting of the "Akdomos" by the Rabbi and the congregation.

Rabbi Lookstein will preach on Wednesday at 11 o'clock. We ask our worshippers to be in their seats before the sermon begins.

On Thursday, the second day of Shavuoth, the Book of Ruth will be read and Yizkor memorial prayers recited.

Shavuoth is the last major festival of the year. As the Festival of Torah it bids us to re-dedicate ourselves to the teachings and traditions of our faith. By our presence in the synagogue on the holiday we reaffirm our loyalty to the Torah.

K. J. Archives

This week an extremely successful Annual Meeting was held in the synagogue. Reports on the congregation's activities, too voluminous to be read aloud, were distributed in booklet form. When the president opened the meeting, he spoke to a full auditorium of members.

'Twas not always so. You might be interested in a few excerpts from annual reports issued about 20 years ago.

The presidential report reads: 1928-

"The outlook for the future . . . is not very rosy. There is, to begin with, something radically wrong with any budget . . . where the expenses and upkeep . . . exceed the income (ed.

note: by about \$5000 in a budger of \$28,000) . . . Spiritually also, the outlook is not encouraging. You are not situated in a neighborhood from which can be drawn much attendance for services or for forums under Orthodox auspices".

1930-

President Joseph Polstein advises that: "A demand should be made for congregational singing; this is very inspiring to the younger element. A Ladies Auxiliary (ed. note: founded the following year) is very essential for a congregation like ours."

In 1929 there were 146 members affiliated with the congregation--a decline of six from the year before.

This year, 1959, some thirty five new members were inducted. How times do change!

SPIRIT OF EXCITEMENT DOMINATES ANNUAL MEETING "IT HAS BEEN A YEAR OF EXTRAORDINARY ACTIVITY, MARKED BY A GREAT INFLUX OF MEMBERS."

In his President's report, Fred Distenfeld pointed out the extraordinary nature of this past congregational year. He remarked how thrilled we were to welcome the new Prime Minister of the State of Israel, Hon. Benyamin Netanyahu, who spent Shabbat with us on his first visit to the United States as Prime Minister. He also spoke of how thrilled we were to welcome Senator Joseph Lieberman to our pulpit on Shabbat YACHAD, a day on which we hosted some forty young people who suffer from a variety of disabilities and who were guided and supported by some eighty Ramaz students and teachers. "It was great to hear a member of the United States Senate speak so comfortably about what it means to be a Shomer Mitzvot in the halls of Congress."

The President also spoke of the physical changes to our building including the emergency repairs on the parapet that borders the roof of the Main Synagogue requiring scaffolding in front of the building for months this winter and the refurbishing of the facade of the synagogue. He also announced the completion of the renovation of the two ladies' bathrooms above the balcony level of the Main Synagogue.

Finally, the President recognized the many members of the congregation who have taken leadership roles in our throughout activities the vear including the Mishloach Manot project, the Dinner Dance, the Social Action, Adult Education, Bikur Cholim and new Political Affairs Committees, and those who chaired special events such as the Purim Seudah. Scholar-in Residence Shabatot, Sukkot meals, Shavuot dinner, Beginner's programs and a host of others in addition to our Sisterhood, Men's Club and Couple's Club and Ketubah.

EIGHTY NEW FAMILIES INDUCTED AT ANNUAL MEETING

Dr. Diana Heller Friedman, past President of the KJ Couple's Club and installed President of the newly Sisterhood presented eighty new families for acceptance into the membership of Kehilath Jeshurun. The record of eighty new families is the largest group of new members ever inducted into membership in any one year. They represent 144 new adults and many, many new children who we welcome into our community. Many of the new members include people who had themselves grown up in this congregation and those who are the children of current members as well as brothers, sisters, nieces, nephews and cousins of current members. Also

included were Ramaz alumni, new Ramaz parents, and some who, please God, hope to be.

Diana remarked that several of our new members have come to us through our Beginner's Service and our monthly Young People's Shabbat minyan. She expressed how proud the congregation is to welcome members who have emigrated to the United States from a number of foreign countries. We are also proud to welcome a number of new members who have already distinguished themselves through their work in the Jewish community and others who are prominent in their professional careers.

In Memoriam


Esther Kolatch


