GIFT POLICIES

- All gifts, at any level, made to The Rabbinic Endowment (Fund) support the Continuity of Community campaign.
- All gifts can be made in honor or in memory of a loved one.
- Donors may pledge gifts over a 3-5 year term and / or make a one-time gift to the campaign.
- Planned Gifts are recorded separately for accounting purposes and dassified as future realized income.

WAYS TO GIVE

- Gifts of Cash.
- Gifts of Securities.
- Planned Gifts: Campaign donors may utilize Planned Gifts as a gift option for participation in the campaign. All Planned Gifts are recorded separately for accounting purposes and are classified as future realized income.

 - Charitable Gift Annuity
 - Charitable Remainder Trust
 - 4. Existing Life Insurance Policy (Temple Judea named as beneficiary)

DONOR DEDICATION POLICIES

- All dedications to The Rabbinic Endowment, Continuity of Community Campaign.
 are available on a first-come, first-served basis.
- Dedications have been created based on campus opportunities that are undedicated to date, have been recently renovated or have been newly constructed.
- Temple Judea has the right to reserve a specific dedication opportunity with the approval of the Senior Rabbi, Temple President and Endowment Board Chair(s).
- Dedication of any unit does not entitle the donor to determine the design and / or the selection of artists.
- Additional unsubscribed dedications may be added or deleted throughout the campaign.
- Dedications of Worship and Torah will be recognized on donor signage but will not be a designated naming. For example, a donor may select the Bimah as a dedication, however they are not permitted to name the Bimah, i.e.
 The Doe Family Bimah is not permitted.
- All noted above applies to all gifts regardless of gift level and or donation vehicle.
- All campaign donors reserve the right to be omitted or listed as anonymous in all published collateral material.
- All donors reserve the right to opt out of their categorized recognition program.



THE RABBINIC ENDOWMENT DONOR RECOGNITION POLICIES

NAMED SPACES: PIONEER TO CHAMPION

Donors of \$250,000 and above will be recognized with an exclusive naming opportunity (excluding dedications of Worship and Torah), i.e. The Frank Family Education Center. Namings will be acknowledged on personalized, campaign, and directional signage, and will be highlighted in all collateral material, press and publicity, on our website, and on social media.

PLEASE NOTE: Those utilizing Planned Gifts for an exclusive naming opportunity will be asked to allocate 50% of their total contribution via a cash gift payable over 3-5 years from date of pledge.

DEDICATION OPPORTUNITIES: FOUNDER TO PROTECTOR

Donors of \$25,000 - \$249,999 may choose an exclusive campaign dedication opportunity.

Gifts will be acknowledged on campaign and directional signage (if applicable) and highlighted in all appropriate collateral material, press and publicity, on our website, and on social media.

PATRON, SUPPORTER & FRIEND

Gifts of \$1,000 - \$24,999 will be acknowledged in all appropriate collateral material, press and publicity, on our website, and on social media.
