Phase 2 planning is also underway and includes the building improvements:

- new sanctuary
- social hall
- lobby
- new kitchen
- new shiur/kids room
- new ADA compliant bathrooms
- new coat room
- new portico and ADA compliant ramp
- all sidewalks that lead directly to the building
- installation of the sprinkler piping from East Willow Tree to the building as well as the indoor sprinkler and fire alarm systems
- removal of the existing driveway
- front and back landscaping

The closing on the sale of the 2 subdivisions is expected later this month. At closing, we will receive \$380,000 as the balance for the sale. Those monies will cover the complete costs of Phase 1 and some portion of Phase 2.
