Frequently Asked Questions

How do I pay my annual commitment?

We make it very easy to pay your annual commitment online. Simply log in to the member portal at harshalomparkcity.org, go to the "my account," "my transactions" tab, and complete payment by credit card or direct debit to your bank account by **Friday, August 11, 2023**. If you prefer, you may send a check for the full balance. You may pay your commitment for the entire year in one payment, or schedule automatic equal installment payments. Installment payments must be completed no later than **Friday, April 26, 2024**.

Is there a fee for paying with a credit card?

Yes, there is a 3% fee that THS must pay when a credit card is used to pay for the annual commitment or make other payments to THS. When paying by credit card, we encourage you to contribute an additional 3% to cover these credit card fees. Last year THS paid nearly \$18,000 for credit card fees. Please note that membership commitment installment payments using a credit or debit card will be charged a 3% convenience fee.

I'm having financial trouble this year. How do I request an annual commitment adjustment?

All are welcome, regardless of ability to pay. The Adjustments Committee is completely confidential and considers all requests for adjustments each year based on financial circumstances. What is the difference between Family and Single Adult Household Memberships?

Single Adult Memberships are not intended for households with more than one adult. If you are part of a family with more than one adult in the household, you should select Family Membership without regard to the religious affiliation of other adults.

Why is there a security fee added to my membership annual commitment?

THS, led by the Security Committee, continues to work diligently to enhance the security at the building. This includes physical improvements, such a public alert system and enhanced security cameras throughout the building as well as hiring uniformed police/sheriff's deputies to be present at religious services and religious school. This is an ongoing and expensive process and additional funds are needed to help defray the costs.

What if I want to support the synagogue, but I do not want to commit to a membership?

Membership commitment fees cover less than 70% of our operating costs. Over half of our members made extraordinary financial efforts to eliminate our Zions mortgage balance. If you choose not to join, please donate to THS at a level that suits you.

Do Temple Har Shalom members need tickets for High Holy Day services?

No, but THS requests that members be in "good standing" to attend High Holy Day services. That means either paying your membership commitment in full or having an installment payment plan in place by **August 11, 2023** and being current on your installment payments. Non-members are welcome to attend High Holy Day Services according to the Admission Policy.

Am I required to make a commitment to a Building Fund?

The recent elimination of our construction-related debt has been achieved by the extraordinary generosity of major donors and with the generous support of existing and past members. We ask all new members who have not contributed to the cost of our facility to make a pledge to the Capital Repair and Replacement Fund. Please make a commitment that is appropriate for your family to assure a future for THS.
